Review of Population Reports

Chairwoman McCastlain reviewed the population reports starting with the ADC report. They have a total count of 18,796. There are about 1,600 in the jails.

Chairwoman McCastlain then reviewed the population report for ACC. They have a total of 2,262.

Chairwoman McCastlain then reviewed the statewide field operations report. There are 22,764 individuals on parole and 35,743 on probation. There is a grand total of 71,337 individuals under supervision.

Ms. Sarah DeBusk-Griffith, Assistant Attorney General, Office of the Attorney General, went over the list of lawsuits that was provided to the Board.

Fiscal Report Update

Ms. Christie Goldman, Business Operations Manager, PPTB, updated the Board on the Fiscal Report. Ms. Goldman reported that effective July 1, 2024, the Agency received funding of \$244,711 for Maintenance & Operations and Conference & Travel for fiscal year 2025. As of February 28, 2025, we've expensed \$101,414.70 (41.44%) of the FY25 Maintenance & Operations and Conference & Travel Budget. At this time last year, the Board had exhausted 48.21% of the operating expense budget.
