#### Call to Order

Chairman Felts called the Board meeting to order at 9:01 a.m. A quorum was declared. All commissioners were noted as being present.

#### Approval of Minutes - April 13, 2023

Vice Chairman Morgan moved for approval of the minutes. Commissioner McCastlain seconded the motion. The minutes were approved as presented.

A copy of the minutes was included in each board member's packet for review.

#### **Review of Population Reports**

Chairman Felts reviewed the population reports starting with the ADC report. He said ADC's population continues to grow. The county jail back up has 2,027 males and 168 females with a combined total of 2,195. There is an in count of 18,076, 16 at ORCU hospital, 7 at other hospitals, 2 out on furlough, and 70 are out to court. There is a grand total of 18,171.

Chairman Felts then reviewed the population report for DCC. They have a total percentage of 103.2%. There was a Board of Corrections meeting in Batesville this past Tuesday. Chairman Felts said that the Secretary discussed with the Board the areas they will be looking at to increase bedding space.

Chairman Felts then reviewed the statewide field operations report. There are 22,845 individuals on parole and 32,938 on probation. There is a grand total of 66,868 individuals under supervision.

#### **Attorney General's Report**

Ms. Nga Mahfouz, Senior Assistant Attorney General, AG's Office, advised the Board that there has been no change since her last report.

#### Fiscal Report Update

Ms. Christie Goldman, Business Operations Manager, APB, updated the Board on the Fiscal Report. Ms. Goldman reported that effective July 1, 2022, the Agency received funding of \$244,711 for Maintenance & Operations and Conference & Travel for fiscal year 2023. As of March 31, 2023, we've expensed \$124,802.70 (51%) of the FY23 Maintenance & Operations and Conference & Travel Budget. At this time last year, the Board had exhausted 47.52% of the operating expense budget.

A copy of the fiscal report was included in each board member's packet for review.

#### **Hearing Judge's Report**

Ms. Brooke D. Cummings, Executive Administrator, APB, updated the Board on revocation hearings conducted throughout the month of March 2023. There were 446 total revocations. There were 334 waivers signed, 29 individuals revoked at a hearing, and 83 administrative revocations.

A copy of the hearing judge report was included in each board member's packet for review.

#### Agency Updates

Ms. Brooke D. Cummings, Executive Administrator, APB, said she's received instructions for the annual operations plan. She said she will begin that process soon. It is planning for FY24.

Chairman Felts mentioned that ACA will be done in July.

#### **Old Business**

There was nothing to report regarding old business.

#### New Business

#### **Files for Review**
