Chairwoman McCastlain called the Board meeting to order at 9:04 a.m. A quorum was declared.

Review of Population Reports

Chairwoman McCastlain reviewed the population reports starting with the ADC report. They have a total count of 18,763.

Chairwoman McCastlain then reviewed the population report for ACC. They have a total of 2,367.

Chairwoman McCastlain then reviewed the statewide field operations report. There are 22,791 individuals on parole and 35,975 on probation. There is a grand total of 71,600 individuals under supervision.

Attorney General's Report

Ms. Jesse Kloss, Attorney General, Office of the Attorney General, went over the list of lawsuits that was provided to the Board. Ms. Kloss mentioned that there are two new cases along with two recently dismissed cases.

Fiscal Report Update

Ms. Christie Goldman, Business Operations Manager, PPTB, updated the Board on the Fiscal Report. Ms. Goldman reported that effective July 1, 2024, the Agency received appropriation of \$2,450,475 for the 2024-2025 Fiscal Year. The current year-to-date expenditures are \$2,212,198.69 (90.77%).
