Review of Population Reports

Chairwoman McCastlain reviewed the population reports starting with the ADC report. They have a grand total of 18,919. They have an in count of 18,816.

Chairwoman McCastlain then reviewed the population report for ACC. They have an in count of 2,171.

Chairwoman McCastlain then reviewed the statewide field operations report. There are 22,585 individuals on parole and 34,846 on probation. There is a grand total of 69,387 individuals under supervision.

Attorney General's Report

Mr. Michael Bynum, Assistant Attorney General, AG's Office, went over the list of lawsuits that was provided to the Board.

Fiscal Report Update

Ms. Christie Goldman, Business Operations Manager, PPTB, updated the Board on the Fiscal Report. Ms. Goldman reported that effective July 1, 2023, the Agency received funding of \$244,711 for Maintenance & Operations and Conference & Travel for fiscal year 2024. As of April 30, 2024, we've expensed \$168,910 (69.02%) of the FY24 Maintenance & Operations and Conference & Travel Budget. At this time last year, the Board had exhausted 65.79% of the operating expense budget.

Mr. Kevin Smith, Executive Administrator, PPTB, updated the Board on agency updates.
