Vice Chairman Morgan then reviewed the population report for ACC. They have an in count of 2,080. They have a grand total of 2,096.

Vice Chairman Morgan then reviewed the statewide field operations report. There are 22,684 individuals on parole and 34,885 on probation. There is a grand total of 69,616 individuals under supervision.

#### **Attorney General's Report**

Mr. Michael Bynum, Assistant Attorney General, AG's Office, went over the list of lawsuits that was provided to the Board.

#### Fiscal Report Update

Ms. Christie Goldman, Business Operations Manager, PPTB, updated the Board on the Fiscal Report. Ms. Goldman reported that effective July 1, 2023, the Agency received funding of \$244,711 for Maintenance & Operations and Conference & Travel for fiscal year 2024. As of May 31, 2024, we've expensed \$171,805 (70.21%) of the FY24 Maintenance & Operations and Conference & Travel Budget. At this time last year, the Board had exhausted 69.47% of the operating expense budget.
