Approval of Minutes - July 11, 2024

Review of Population Reports

Chairwoman McCastlain reviewed the population reports starting with the ADC report. They have an in count of 18,855.

Chairwoman McCastlain then reviewed the population report for ACC. They have an in count of 2,137.

Chairwoman McCastlain then reviewed the statewide field operations report. There are 22,682 individuals on parole and 34,867 on probation. There is a grand total of 69,625 individuals under supervision.

Attorney General's Report

Ms. Julie Chavis, Senior Assistant Attorney General, AG's Office, went over the list of lawsuits that was provided to the Board. The only change noted was for number 11 in the report. A writ of mandamus was granted by the court.

Fiscal Report Update

Ms. Christie Goldman, Business Operations Manager, PPTB, updated the Board on the Fiscal Report. Ms. Goldman reported that effective July 1, 2023, the Agency received funding of \$244,711 for Maintenance & Operations and Conference & Travel for fiscal year 2024. As of May 31, 2024, we've expensed \$171,805 (70.21%) of the FY24 Maintenance & Operations and Conference & Travel Budget. At this time last year, the Board had exhausted 69.47% of the operating expense budget.
