Supplement to January 2018 Seriousness Reference Table

RE: **ADVISORY** Target Offense Designations

It has come to our attention that some offenses were inadvertently omitted from the list of potential target offenses in the advisory designation column of the Seriousness Reference Table published in January of 2018. These designations will be updated in the upcoming revision, which will also incorporate new seriousness rankings resulting from criminal legislation adopted during the 2019 legislative session. Until the new Seriousness Reference Table is published, please consider the below offenses to be **possible** target offenses. Please note that these target offense designations are made to be helpful, but are **ADVISORY ONLY**. Refer to A.C.A. §§ 16-93-1201 et seq. for legal definitions. You may also contact the Division of Community Correction or Division of Correction, as appropriate, for specific questions regarding whether a particular offense qualifies as a target offense.
