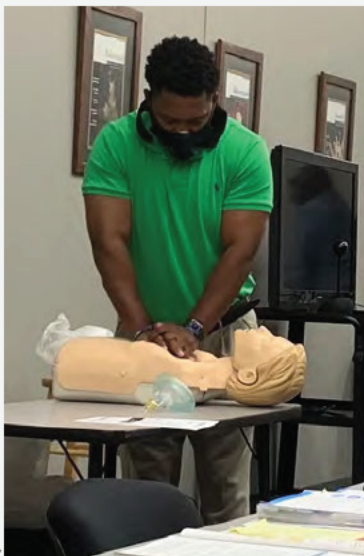

From the Director



The October Parole & Probation Academy graduating class took steps to remember a fallen hero by purchasing and presenting a framed American flag to the family of the late Pine Bluff Police Detective Kevin Collins. Collins, a Pine Bluff police detective who was shot and killed in the line of duty on October 5, was responding to a call and is the first Pine Bluff officer killed in the line of duty since 1985. A five-year veteran of the Pine Bluff Police Department, Collins was just 35 years old. He leaves behind an incredible legacy of service, volunteer spirit, and love. In 2017, he was named Officer of the Year after he responded to a fire and rescued a 95-year-old woman from a burning building.

ACC staff also presented a framed flag to the family of Travis Wallace who was a Helena-West Helena Police Officer who died in the line of duty. Wallace, a former ADC employee, died after a gun battle with a wanted suspect who was later captured in Mississippi by U.S. Marshals. Wallace was considered a “true leader” who loved his community, according to the Helena-West Helena Police Chief. Wallace, shown at right taking an ACC training class on CPR earlier this year, was with the police department for the past five years.



Institutional Release Officer Angela Robinson, who is shown at right, was named Employee of the Year at ADC's Randall L Williams unit. Robinson is an ACC employee stationed at the unit.



ACC's new building on Pike Avenue (and DOC's new headquarters) was the site of a Governor's Cabinet meeting earlier this year and, in response to the hospitality shown, Governor Hutchison sent a letter of appreciation to Director Bradshaw and staff. Area 11 Agent Gavin Johnston attended the event in Monticello at Walmart. He assisted local law enforcement agencies in collecting unused prescription medication from the community. Agent Tonya Robinson attended the event in Pine Bluff. She assisted local law enforcement agencies in collecting unused prescription medication from the community.



Area 10 Agent Brandon Peachey and a Malvern police officer sponsored a Drug Take Back Program at the Malvern Walmart (below).



Area 4 Agents Ashley Stuart and Bryan Hook, along with Hook's daughter, assisted the Jonesboro Police Department with the Prescription Drug Take Back event at the Jonesboro Sam's Club location. There were three different



locations set up during the day for citizens to be able to drop off unused or expired medications. There is also a permanent drop box location available to the public 24 hours a day year-round at the Jonesboro Police Department. The event on October 24 collected 38.4 pounds and since August 2020, a total of 281.4 pounds has been collected.

Area 2 Agents Cody Gilbert and Nick Mayfield of Mountain Home conducted a home visit on a parolee who is also a registered sex offender and discovered drugs. The offender was taken into custody by Baxter County Sheriff's Department with pending felony charges.



Area 8 Agents Ryan Gordon and Kristin Andrews and Officers Paige Sullivan and Dylan Burke conducted a home visit in Jacksonville and found suspected meth,



a few pipes and suspected marijuana. The offender was arrested.

Intensive Parole Supervision (IPS) officers in **Area 8** found weapons and drugs in the cars and homes of two offenders. Items confiscated from the two were 2.5 lbs of marijuana, 1 handgun, 2 AR rifles, \$6,000 in US currency, and a Lexus.



A weapon and marijuana were found in the home of an offender who was reportedly involved in narcotics sales. IPS officers, working with Little Rock Police, found various items of drug paraphernalia, 7 grams marijuana, and a Springfield .45 pistol.

Area 8 Assistant Area Manager Demetrick Warren, and Agents Brittney Freeman and Felicia Hester completed a home

visit for the sex offender Halloween compliance check and found roughly 7.4 grams of Methamphetamine, 1.7 grams of Cocaine, 5 Oxycodone pills,



and 3 digital scales (1 with residue). The Little Rock Police Department along with the Narcotics team was called for assistance. The sex offender, along with another offender in the residence, was arrested.

Area 8 recognized employees of the month. In September it was Agent Kenya Hill. Managers in the area noted that "each morning when she comes in she always greets me with a friendly word and anytime that I have reached out to her for help or assistance she has been willing to assist with no questions asked. Every time that I have had any interactions with her, she has always been professional and courteous." In October it was Agent Detonda Woolfolk. Speaking of Woolfolk, managers said, "she is always willing to help." Woolfolk

volunteered to be included in the new website page, she's a team player, and displays the ability to acknowledge her purpose for being here and helping with a mentally unstable offender.

Treatment Program Summary:

690 Probationers and Parolees were served in the general Substance Use Disorder Treatment Programs. Additionally 1,179 participants were served in the Drug Court Treatment Programs, bringing the total served to 1,869.

A total of 471 residents have agreed to participate in Medication Assisted Treatment (MAT) since the program started in July 2018; 189 are discharged with follow up in progress in the community; and 39 have completed the program. Partnership is in effect with 57 Community Providers to continue MAT upon release from the Centers.

General Treatment Program Summary (Non-Drug Court):

Substance Use Disorder Treatment - 447 participants
Case Management - 70 participants
Continuing Care - 159 participants
Domestic Violence Prevention - 5 participants
Life Skills - 15 participants
Tobacco Use Treatment - 4 participants

Assistant Director for Reentry Services Carrie Williams, Volunteer Coordinator Ardella Bearden, and Reentry Officer Mallory York met with esa Staffing, Intimidator Group and Work force Services in White County and developed a working partnership as a second chance employer (picture below).



ACC currently has 7 licensed reentry facilities with 175 total residents currently in Phases I-IV of the Reentry Facility Program. There was a total of 10 reentry graduates during October.

Monthly statistics include:

33 new residents were transferred into the reentry program
2 residents started GED classes
1 resident earned a GED
2 residents earned a Career Readiness Certificate
22 residents received their driver's license
22 received an ID card
27 received their SS card
16 received birth certificates
171 facility residents were reported to be employed 21 residents are ineligible for employment at this time.

Reentry Officers conducted 185 reentry facility office visits, 34 Phase IV office visits, 126 Phase IV home visits, and 66 Pre-PPVs.

Transitional Housing:

A total of 20 licensed facilities with 465 ACC funded beds. Within the transitional facilities there are a total of 199 residents who have obtained full time employment, 41 part time employed and 45 are drawing disability. Monthly statistics include:
8 residents enrolled in GED classes,
6 residents started the Career Readiness Certificate program
75 registered sex offenders are living in a transitional facility.
36 residents received their driver's license
113 received an ID card

94 received their Social Security card
43 received birth certificates
59 graduated from the transitional housing program.
61 absconded
42 were dismissed

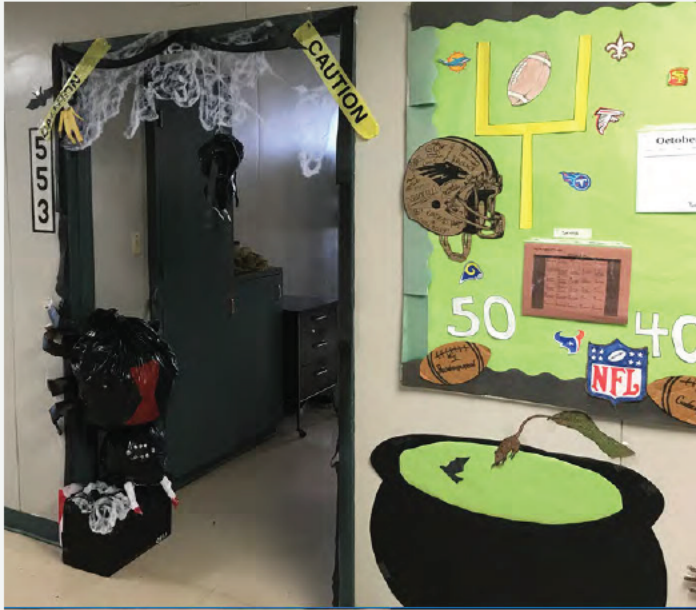
The Good Grid:

There are approximately 944 service providers registered in Good Grid, a total of 67,042 supervi-

sion accounts and 11,929 inmate registered accounts. There are currently 2,144 visible resumes.

Arkansas Works:

During the month there were approximately 211 individuals who were screened for the Arkansas Works program. There were a total 732 individuals who submitted an application and 672 who enrolled in a "Qualified Health Plan" as reported by Eaton Agency.

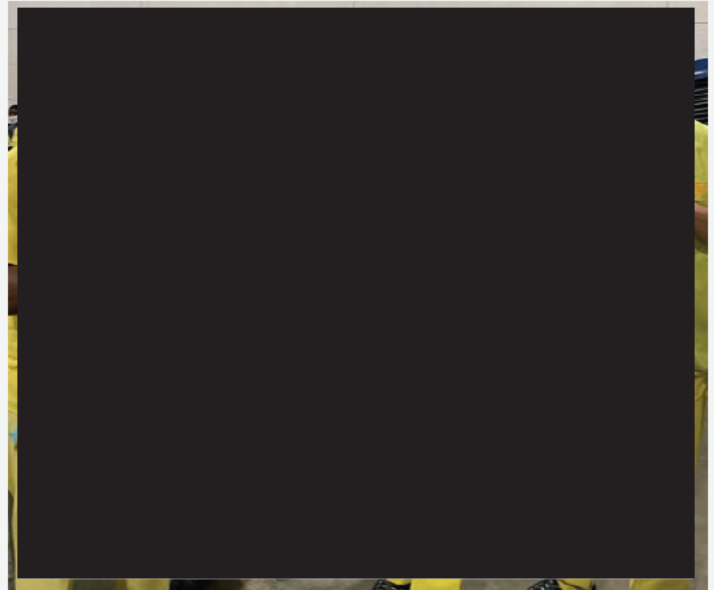

Graduation was held for October at the **Central Arkansas Center** and each resident received two ties to take upon leaving the facility. The ties were donated by a local church (below).



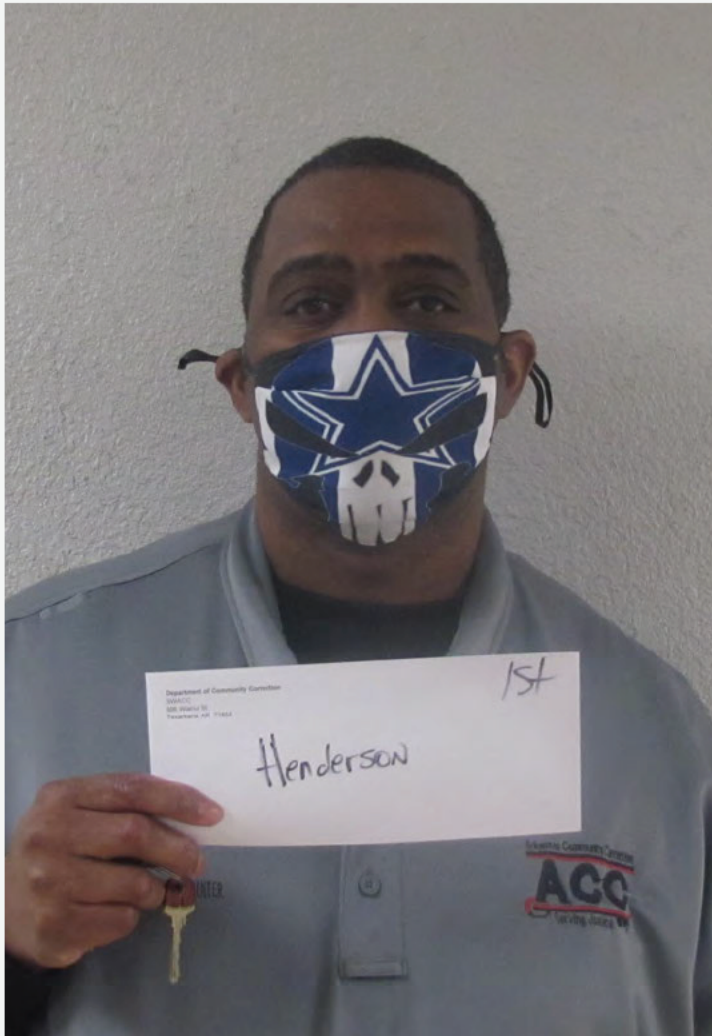

Halloween is an event of utmost importance to those involved in sex offender management as festivities are largely catered to minors. This year, sex offender involvement in Halloween events continued to be strictly prohibited. Historically, sex offender lock-ins are held where sex offenders report to a parole/probation office to be supervised during peak trick-or-treat times, however, due to COVID-19 pandemic safety precautions which limit large gatherings, lock-ins were not held. Home detention coupled with random home visits to check for compliance was implemented statewide.

Halloween restrictions were directed toward sex offenders on supervision for an active sexual offense targeting the highest risk sex offenders for home verification and compliance.

ACC officers only excluded those sex offenders who were required to work on Halloween with verification provided by their employer.

A mandatory curfew from 5 p.m. October 31 through 6 a.m. November 1 was issued. Sex offenders subject to house detention were prohibited from distributing candy and were directed to have all lights out with no Halloween decor outside their residence.

This year's ACC Halloween initiative was successful. ACC actively supervises 646 Community Notification Level (CNL) 3 and 4 Sex Offenders. All identified sexual offenders were placed on home detention with random home visits completed. Every CNL 4 Sexually Dangerous Person (SDP) on active supervision was subject to a home visit on Halloween. A total of 640 home visits were conducted and of that number, 59 offenders were in violation which equates to a 92% compliance rate. Some of the violations included: moved from registered address, failure to register, failure to register internet identifiers, felony possession of drugs charges, felon in possession of a firearm, Halloween decorations violation of Act 436, children at residence, trick or treaters/lights on, failed to display no trick or treaters door hanger, failed to abide by home detention directive, were not at home.

Kendrick (at right) and others spoke to honor Stone County Deputy Mike Stephen who lost his life in the line of duty.

Indirect: These are offenders for whom their sentence, circumstance, or current status is associated with a reduced supervision obligation for the officers they are assigned to. Generally, these include offenders in non-reporting status, those on suspended sentences (SIS), and interstate compact offenders. Offenders on annual supervision are also included in this group.

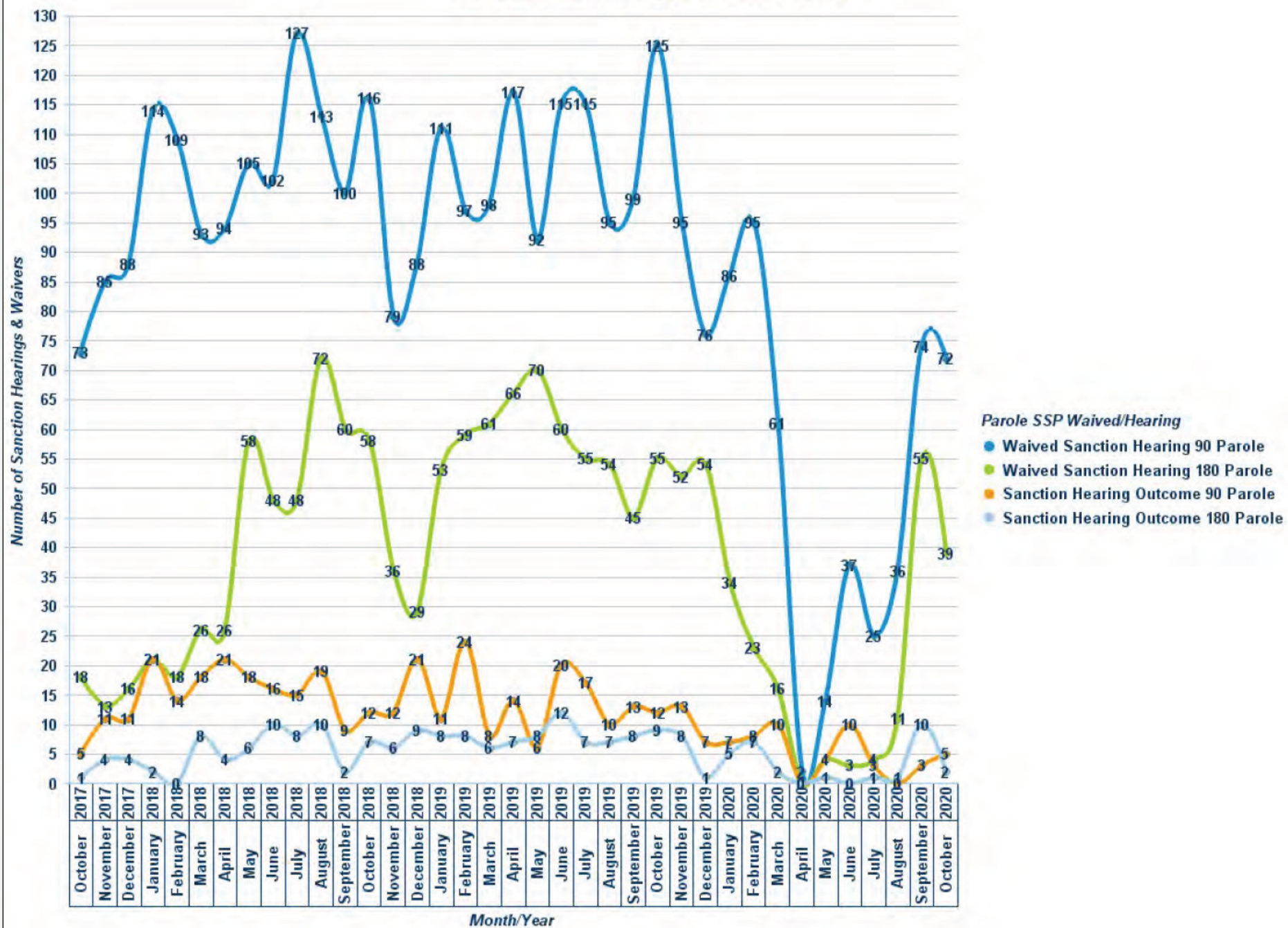
