From the Director

Under the leadership of Assistant Area Manager Dr. Debra James, **Area 8** (Little Rock/North Little Rock) has become proactive in community service work. As shown in the photos at right and below, work has included washing cars and picking up trash near roadways as part of a city of Little Rock cleanup effort and as far away as Bradley County. The group also has been working inside DOC headquarters as a cleaning crew.



In honor of Women's History Month, which is held each March, the University of Arkansas at Pine Bluff's Family and Consumer Sciences (FCS) Department recognized Marcie Johnson who works in ACC's Parole/Probation Treatment Services section in Jefferson County. For the last three years, Johnson, a UAPB alumna, has gone the extra mile to market UAPB-FCS programming to her clients and the community. Johnson has worked for the ACC for 17 years and is currently serving as advisor with Jefferson County Drug Court. She likes to refer to drug court as a "second chance program" because they offer their clients the opportunity to restore their lives. The division



provides clients with the necessary skills to live a drug and alcohol free lifestyle and to become contributing members of society. Johnson plays an integral part with the UAPB 1890 Cooperative Extension Program. She serves on the 1890 Cooperative Extension Nutrition Advisory Council, where she provides her expertise on how to better serve the citizens in Jefferson County. She also works with the Expanded Food and Nutrition Education Program (EFNEP) personnel to provide nutrition education and cooking skills to her clients, so they acquire the knowledge and tools to help their families. Johnson regularly joins UAPB nutrition lessons to help encourage her clients to participate as well. She is an ongoing advocate for EFNEP, as she continually encourages her staff to participate and try the program's healthy recipes.

Area 2 agents helped with accident scenes in remote areas of the counties in which they conduct home visits. In early March, two agents discovered an offender with firearms when they came upon an accident while conducting home visits in Stone County. Agents Jimmy Carter and Cody Cassell assisted emergency personnel on the scene of a rollover accident until local law enforcement arrived. Agent Carter observed a firearm on the injured man's waist and he cleared the weapon and placed it in a safe location until other law enforcement arrived. Agent Carter observed a shotgun inside of the subject's vehicle and treated this weapon in the same manor. Agent Carter submitted the weapons to Arkansas State Police when they arrived on the scene. The subject was identified as a felon and he was charged with Possession of a Firearm by Certain Persons as well as misdemeanor Possession of a Controlled Substance and Drug Paraphernalia. Later in the month, Agents David Beaty and Nick Mayfield happened upon a vehicle which had left the roadway and an elderly woman was climbing out of the driver's side window. Agent Mayfield contacted Marion County Sheriff's Department while Agent Beaty assessed the situation. The woman did not appear to be injured, but agents stayed with her until a sheriff's deputy arrived. And a day later Agent Steve Simers assisted local law enforcement in working a fatality



accident in Fulton County.

The Harrison Parole/Probation Office (**Area 2**) received and installed a new sign at their new location.



Area 6 Officer Heike McKinney participated in the 5th annual Will McGary Tribute Race at I-30 Speedway with several law enforcement departments present. Officer McGary was a Conway police officer killed in the line of duty by a drunk driver.



Area 6 Parole and Probation Officers Chelsea Slechta, Vladimir Gomez and Brittany Hensley (shown below) graduated from ACC's virtual parole and probation academy.





Officers in **Area 5** brought home seven of the 10 awards given in ACC's Virtual Parole and Probation Academy. Graduates are shown above, from left to right: Officer Bart Robertson, 3rd place Physical Fitness Award; Officer Chase Ridenour, 2nd place Firearms (tied) and 2nd place Academics; Officer Cremonia Bridges, 1st place Academic Award; Officer Devin Deresa, 1st place Physical Fitness and 2nd place Firearms (tied); and Officer Chad Davis, 3rd place Firearms.

Career Planning and Placement Specialist Paula Cox (**Area 5**) put together a litter crew to clean up trash and debris on Polk Road 77 in Mena (shown below).



Area 2 Officer Hunter Boles and Agent Steve Simers along with officers of the Fulton County Sheriff's Department conducted a home visit at the residence of a parolee and discovered approximately 70 grams of a white crystalline substance that field tested positive for methamphetamine as well as a significant amount of drug paraphernalia. Another offender was in the home and both were charged with Possession of a Controlled Substance with the Purpose to Deliver, to wit: Methamphetamine greater than ten grams but less than 200 grams. Later in the month, Simers conducted a home visit at the residence of a probationer and during a pat down search of the offender revealed glass smoking device commonly used for ingesting methamphetamine in the man's front pants pocket. The offender admitted to smoking methamphetamine the same day. Also located in the residence was a small plastic container with a small plastic baggie that contained a green leafy substance consistent with the appearance of marijuana and a small plastic baggie with a white crystalline substance/residue that appeared to be methamphetamine. A former probationer also was in the home along with a 7-month-old child. The female offender had an outstanding warrant for felony Assault on a Law Enforcement Officer. The offender and the woman were taken into custody.

In Sebastian County (**Area 5**) officers arrested an offender on a Failure to Appear Warrant. A search conducted of the offender's home yielded a gun cabinet full of weapons, several 22 gauge shot guns, boxes and bags of ammunition including a box of Winchester Super - X 22 short high velocity rimfire cartridges, 2

boxes of Winchester 12 gauge shells, CCI 22 long rifle hollow point mini mag, Monarch 380 auto brass case, among others. The offender was taken into custody. Photo below:



Agents with the **Area 8** Intensive Parole Supervision received information that an offender was selling narcotics and when they conducted a home visit, found designer marijuana and MDMA. In total 88 MDMA pills, 1.5 ounces of heroin, 27 grams of fentanyl, and \$4,700 were seized from the residence by Little Rock Police. The offender was charged with Maintaining a Drug Premises, Possession of Controlled Substance with Intent Schedule I,II < 2 Grams, Possession of Drug Paraphernalia, Possession of Schedule VI Controlled Substance with Intent < 14 Grams and Possession with Purpose to Deliver Controlled Substance Schedule I.

An offender was found to have methamphetamine and fentanyl in his possession when he was stopped by Little Rock Police. The offender admitted to more of both substances in his home and **Area 8** agents found digital scales, needles with suspected residue, and NARCAN along with two additional offenders - including an absconder - in the home. Violations reports were completed and submitted on all three offenders.

Methamphetamine and LSD were discovered by **Area 8** agents who acted on a tip and conducted a home visit on a residence in North Little Rock. Agents also found a probation absconder in the residence. Both offenders were arrested and transported to Pulaski County.

Another tip to Intensive Parole Supervision agents in

Area 8 resulted in the discovery of 38 grams of suspected methamphetamine, a glass pipe with residue, plastic baggies, and a scale in an offender's Little Rock home. The offender was transported to the Little Rock Police Department for questioning. A petition for revocation will be submitted when charges are finalized.

Tips continued to come in to IPS agents who were told of narcotics activity at an offender's home in Little Rock. Officers conducted a home visit and discovered a fully loaded Draco pistol and 2 AR-15 rifles loaded with 65 round drums (shown below). The offender was transported to the Little Rock Police Department for questioning. A petition for revocation will be submitted when charges are finalized. All evidence was collected by LRPD.



Area 4 held their first CPR/First Aid recertification class using their new CPR and first aid equipment. There were 9 people in attendance. Masks and social distancing guidelines were observed. Area 4 is appreciative to have their own equipment to utilize for training.

Area 10 Officer Richard Perry and Assistant Area Manager Angela Tjelmeland conducted a home visit accompanied by the Saline County Sherriff's Office and Benton Police Department on a sex offender wanted for questioning regarding Fraudulent Use of Credit Device and suspected of Failure to Comply with Sex Offender Registration. During the home visit, it was discovered the offender shot and killed his grandmother's dog and two of her geese with a BB gun earlier in the day. The offender was transported to Saline Memorial for detox and felony charges have since been filed.

Staff in the Sheridan office (**Area 10**) conducted a

home visit and discovered marijuana, drug paraphernalia and methamphetamines. The offender was taken into custody.

A cache of weaponry was found by **Area 10** officers David Sanford, Kameron Blevins, Justin Stewart, and Zachary Evans during a home visit. The offender was reported to have weapons and the search revealed a crossbow, a machete, a sword and knives. Drug paraphernalia also was located. The items (shown below) were confiscated.



The 2nd Judicial Drug Court team (**Area 4**) saw seven participants graduate from the program. Each participant was able to bring two guests who have supported them through their journey. The 2nd Judicial Drug Court Program is a 12-month diversion program for those with a drug or alcohol addiction. The program provides intense counseling, group sessions, individual sessions, and supervision while the participants are learning the tools to live a clean and sober lifestyle. Special guest Jonesboro Mayor Harold Copenhaver and his staff were in attendance along with 2nd Judicial Prosecutor Keith Chrestman.

Mississippi County Sheriff's Department Drug Task Force, Sheriff's Street Crimes Unit and agents from Probation and Parole (**Area 4**) were in the Keiser area to conduct a home visit when they discovered drugs in an offender's vehicle when the offender stopped at a nearby store. Found in the offender's car was Crown Royal bag containing two baggies of suspected methamphetamine (approximately 18.5 grams), 11 clonazepam pills, 2 dextroamphetamine pills, pipe used for smoking methamphetamine and a set of digital scales. The offender was taken into custody.

Polygraph/CVSA Examiners have returned to conducting examinations in risk-reduced, quality-controlled examination sites throughout Arkansas. During one such exam, it was discovered that a probationer - with a misdemeanor sex offense for secretly filming a 10-year-old girl undressing - had established an intimate relationship with a woman who has four minor children, aged 1 to 7 years old. The offender was actively babysitting these minors, has had unsupervised, physical contact with these minors, and had even slept in the same bed with one of the minors in violation of the conditions of his supervision. Notification was made to the Arkansas State Police Child Abuse Hotline.

The **Central Arkansas Center** in Little Rock has begun having volunteers do peer support bible study for each wing. Pictured below is James Shelton from Promised Land. He is one of two volunteers who have started at the facility.



The men's Fraternity program was held on C Wing for residents and seven completed the program and received a certificate. The class was facilitated by Chaplain Mead.

Staff at the **Northwest Center** in Fayetteville were treated to barbeque dinners by a local restaurateur. Nate Well Jr., who owns Secondhand Smoke BBQ donates frequently to first responders. Shown below is Corporal Tori Copeland with a barbeque plate.



Classes for residents were the highlight of March at the **Southwest Center** in Texarkana. The Department of Workforce Services gave a class on job seeking, with 15 residents attending the presentation. A Grace for Addictions Class was held for the 3rd floor residents with four residents participating and completing the program. The class was taught by volunteer Anna Hensley. The 33 Series: Authentic Manhood Class, Volume I was held for residents in the Supervision Sanction Program. Twelve completed the 1st volume of Authentic Manhood. The class was taught by volunteer Richard New. A Purpose Driven Life Course was held for the 4th floor residents - with 10 completing the program. The class was taught by volunteer Antionette Watson.

Pakita Smith promoted to treatment coordinator at the **East Central Arkansas Center** in West Memphis. She began working for the state 10 years ago and has worked at ECAC for five years. Her job is to oversee staff and to ensure they are getting the necessary trainings, observations, and assisting them with preparing for



Alcohol and Drug Certification. Smith has a passion for helping people and enjoys working in a positive atmosphere.

Nasstacia Speed recently promoted to treatment coordinator. She began working at **East Central Arkansas Center** four years ago. She provides supervision, staff development, education, and continued care for the residents. Speed shared that she enjoys her job because she has always wanted to be a counselor since childhood due to being intrigued with the study of the mind.



Treatment Program Summary:

711 probationers and parolees were served in the general Substance Use Disorder Treatment programs. Additionally 1,003 participants were served in the Drug Court Treatment programs, bringing the total served to 1,714.

A total of 498 residents have agreed to participate in Medication Assisted Treatment (MAT) since the program started in July 2018; 231 are discharged with follow up in progress in the community; and 59 have completed the program. Partnership is in effect with 59 Community Providers to continue MAT upon release from the Centers.

Reentry Facilities:

ACC has 7 licensed reentry facilities with 235 total residents currently in Phases I-IV of the Reentry Facility program. There were 44 reentry graduates during March. Also during March, 52 new residents were transferred into the reentry program, 34 residents started WAGE classes, 21 residents completed WAGE,

63 residents started the Career Readiness Certificate program, 20 residents completed the program and 12 residents started GED classes. A total of 59 reentry facility residents received their driver's license, 68 received an ID card, 76 received their Social Security card and 44 received birth certificates.

Reentry Officers:

Reentry officers reported 7 education referrals that resulted in an education enrollment. They conducted 234 reentry facility office visits, 171 Phase IV office visits, 52 Phase IV home visits, and 65 Pre-PPVs. Reentry officers made 57 community contacts within their assigned area during the month.

Transitional Housing:

There are 22 licensed facilities with 587 beds with 434 ACC-funded residents.

Within the transitional facilities there are a total of 257 residents who have obtained full time employment, 23 part-time employed, 26 receiving disability and 128 are pending employment and/or left the facility prior

to obtaining employment.

During March, 11 residents reported to have enrolled in GED classes, and there are 67 registered sex offenders living in a transitional facilities.

A total of 25 residents received their driver's license, 81 received an ID card, 58 received their Social Security card and 26 received birth certificates.

A total of 44 residents graduated the transitional housing program, 55 absconded, and 27 were dismissed.

Volunteer Program:

Twenty volunteers reported a total of 437 hours during the month.

Arkansas Works:

During March, there were approximately 395 individuals screened for the Arkansas Works program; 753 individuals who submitted applications and 483 who enrolled in a "Qualified Health Plan" as reported by Eaton Agency.

Specialty Court: These officers supervise offenders in specialty courts. Note that these officers may also carry regular P&P offenders, and these offenders are reflected in the specialty court caseload/workload figures; however, separate caseload/workload ratios are calculated for the regular and specialty court portions of a specialty court officer's caseload, in addition to a combined, or mixed, ratio.

Specialized: These officers supervise strategically specialized caseloads consisting of offenders requiring heightened supervision protocols (intensive supervision) and parolees who have absconded supervision (Special Response Team).

Indirect: These are offenders for whom their sentence, circumstance, or current status is associated with a reduced supervision obligation for the officers they are assigned to. Generally, these include offenders in non-reporting status, those on suspended sentences (SIS), and interstate compact offenders. Offenders on annual supervision are also included in this group.

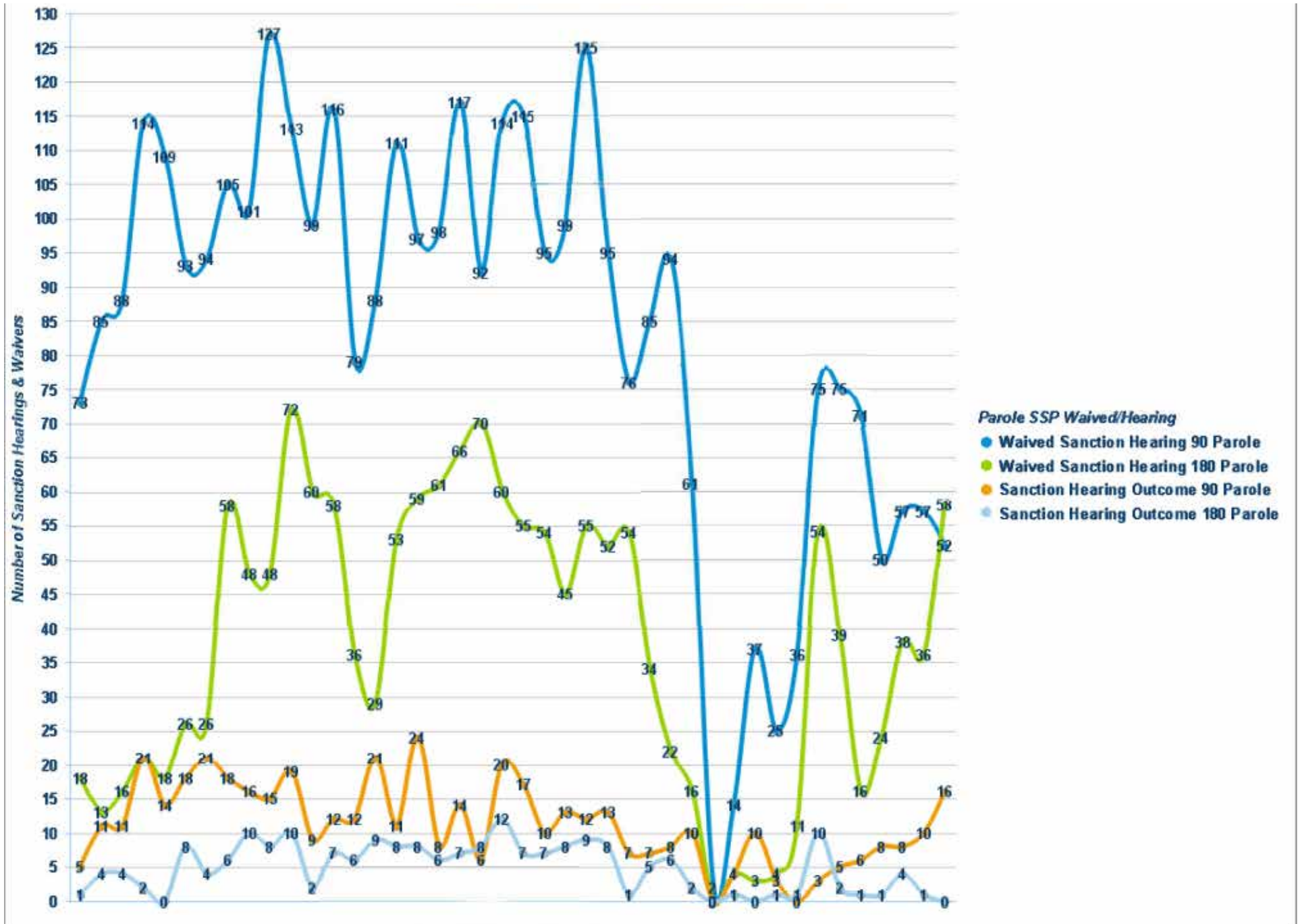
