From the Director

Tameka Coleman has been named assistant center supervisor at the **East Central Center** in West Memphis. Coleman began her career with corrections in 2002 with the Arkansas Department of Corrections. For 14



years she has received training and advancement since starting out as a corrections officer 1 and promoting through the ranks to become a disciplinary hearing officer. In 2016 she joined Arkansas Community Correction as one of the first employees hired for the West Memphis center. Coleman continued advanced training and professional development to better understand clinical services in a Modified Therapeutic Community and programming in corrections. Having started as an advisor for ECACC she was promoted to substance abuse program leader (SAPL) in 2017 and obtained her Alcohol & Drug Counselor Certification in 2019. In 2020 she was promoted to deputy warden for the Randall L. Williams Unit in Pine Bluff overseeing the overall operations and programs of the facility. Welcome back to ECACC Assistant Center Supervisor Coleman.

Serena Brawley was promoted to **Area 11** assistant area manager for Arkansas, Cleveland, and Jefferson counties. Brawley obtained a bachelor's degree in Marketing/Management from the University of Central Arkansas at Conway in 2005 and worked as a Patrol Officer for the North Little Rock Police Department

from August 2006 until January 2011. She started her career with Arkansas Community Correction as a parole/probation officer in January 2011 at the Garland County Office. She transferred to the Saline County Office in March 2011 and then in February of 2012 was given



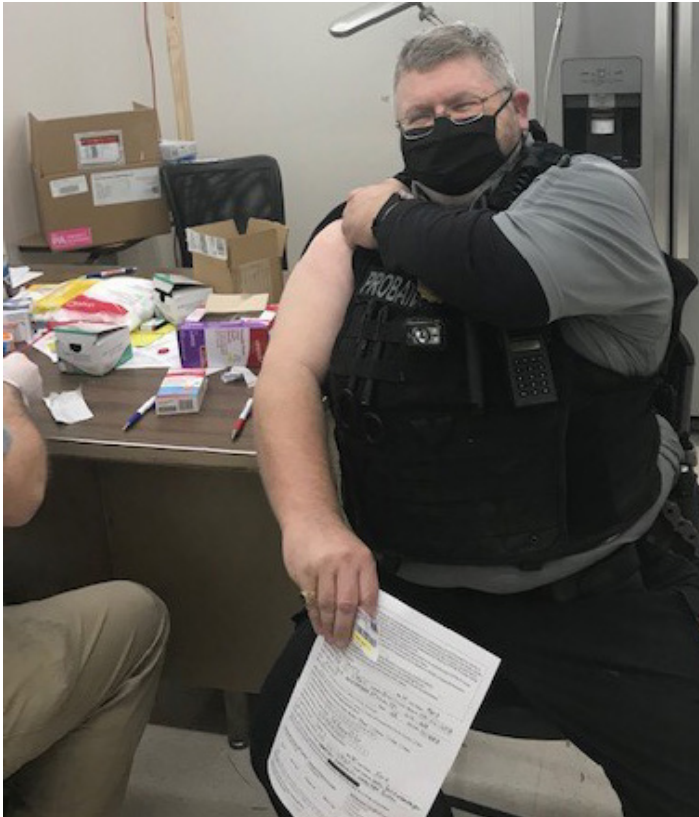

Area 2 Agent Steve Simers conducted a transfer request investigation in Fulton County on an offender and discovered drugs and weapons. When approached, Simers found the offender had a Taurus 9 mm handgun in his waistband and a search revealed a clear plastic baggie which contained four smaller plastic baggies containing a white crystalline substance, digital scales, a torch lighter, and a red plastic baggie containing a substance suspected to be synthetic marijuana. Inside the vehicle, Agent Simers discovered a large amount of cash and a black handled machete. The offender was taken into custody by Fulton County Sheriff's Department. The crystalline substance later tested positive for methamphetamine and had a total weight of 17.5 grams.

Officer of the Quarter presented to Officer Jerrica Dutton:

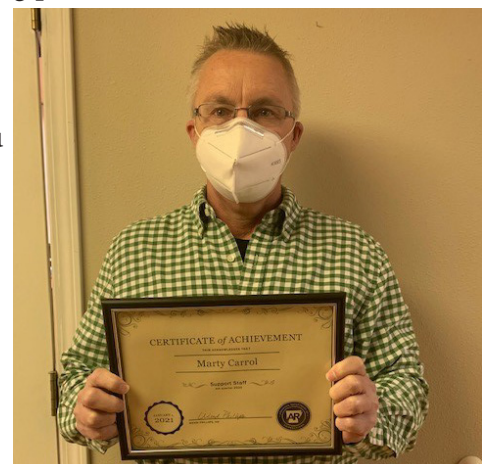

January Treatment Program Summary:

635 probationers and parolees were served in the general Substance Use Disorder Treatment Programs. Additionally 1,060 participants were served in the Drug Court Treatment Programs, bringing the total served to 1,695.

A total of 480 residents have agreed to participate in Medication Assisted Treatment (MAT) since the program started in July 2018; 222 are discharged with follow up in progress in the community; and 50 have completed the program. Partnerships are in effect with 59 community providers to continue MAT upon release from the Centers.

General Treatment Program Summary (Non-Drug Court):

Substance Use Disorder Treatment - 401 participants
Case Management - 70 participants
Continuing Care - 154 participants
Domestic Violence Prevention - 3 participants
Life Skills - 14 participants
Tobacco Use Treatment - 5 participants

The new Mental Health Court in Sebastian County pled in their first participant on January 7. Eventually, the court plans to include Crawford County participants.

Reentry Facilities:

As of January, ACC has seven licensed reentry facilities with 233 residents currently in Phase I-IV of the Reentry Facility Program. There 14 graduates from the program this month.

During the month, 35 new residents were transferred into the reentry program, 6 residents started WAGE classes, 9 residents completed WAGE, and 1 resident started GED classes. 16 residents started Career Readiness Certification (CRC) and 4 residents completed CRC. Eleven residents received their driver's license, 8 received an ID card, 12 received their Social Security card and 11 received birth certificates.

Reentry Officers:

In January, reentry officers reported four education referrals that resulted in an education enrollment. They also conducted 132 reentry facility office visits, 113 Phase IV office visits, 26 Phase IV home visits, and 78 Pre-PPVs.

Transitional Housing:

There are 433 ACC-funded residents in a transitional facility.

Within the transitional facilities there are 193 residents who have obtained full time employment, 24 have part time employment and 29 are receiving disability.

During January, 5 residents reported to have enrolled in GED classes and 1 completed, 6 residents started

Career Readiness Certification.

Ten received their driver's license, 69 received an ID card, 30 received their Social Security card and 24 received birth certificates.

There are 71 registered sex offenders living in a transitional facility.

Volunteers:

Ardella Bearden, Mentor Coordinator, conducted four volunteer trainings last month and one new volunteer trained in January.

Employment:

During January, there were 360 residents reported to have full-time employment within reentry and transitional facilities.

The Good Grid:

There are approximately 944 service providers registered in Good Grid, a total of 67,094 supervision accounts and 11,798 inmate registered accounts. There are currently 2,115 visible resumes. There have been 11,673 resumes updated since January 2017.

Arkansas Works:

During January, approximately 234 individuals were screened for the Arkansas Works program. There were 651 individuals who submitted an application and 576 who enrolled in a "Qualified Health Plan" as reported by Eaton Agency.

Dr. Debra James and Demetrick Warrent, both assistant area managers in North Little Rock, were featured in an article in the January edition of the Adult Education newsletter.

Division of Community Corrections (DCC) Connects with the Division of Workforce Services Adult Education Section

Dr. Debra James, a Probation/Parole Agent, and Assistant Area Manager Demetrick Warren with DCC participated in a panel discussion for the Adult Education Section professional development training titled Reentry Matters: Tailoring Career Services for Specific Populations, held on November 13, 2020. The panel discussion was held to provide our local adult education career coaches an overview/insight of their intake process, meeting the criminogenic needs of returning citizens, and how parole and probations officers assist returning citizens with finding employment. The training provided information on how career services can be tailored to meet the workplace needs of returning citizens. Emphasis was placed on strategies, techniques, and resources designed to equip the adult learner with the skills necessary to be successful in a global workforce

Specialized: These officers supervise strategically specialized caseloads consisting of offenders requiring heightened supervision protocols (intensive supervision) and parolees who have absconded supervision (Special Response Team).

Indirect: These are offenders for whom their sentence, circumstance, or current status is associated with a reduced supervision obligation for the officers they are assigned to. Generally, these include offenders in non-reporting status, those on suspended sentences (SIS), and interstate compact offenders. Offenders on annual supervision are also included in this group.

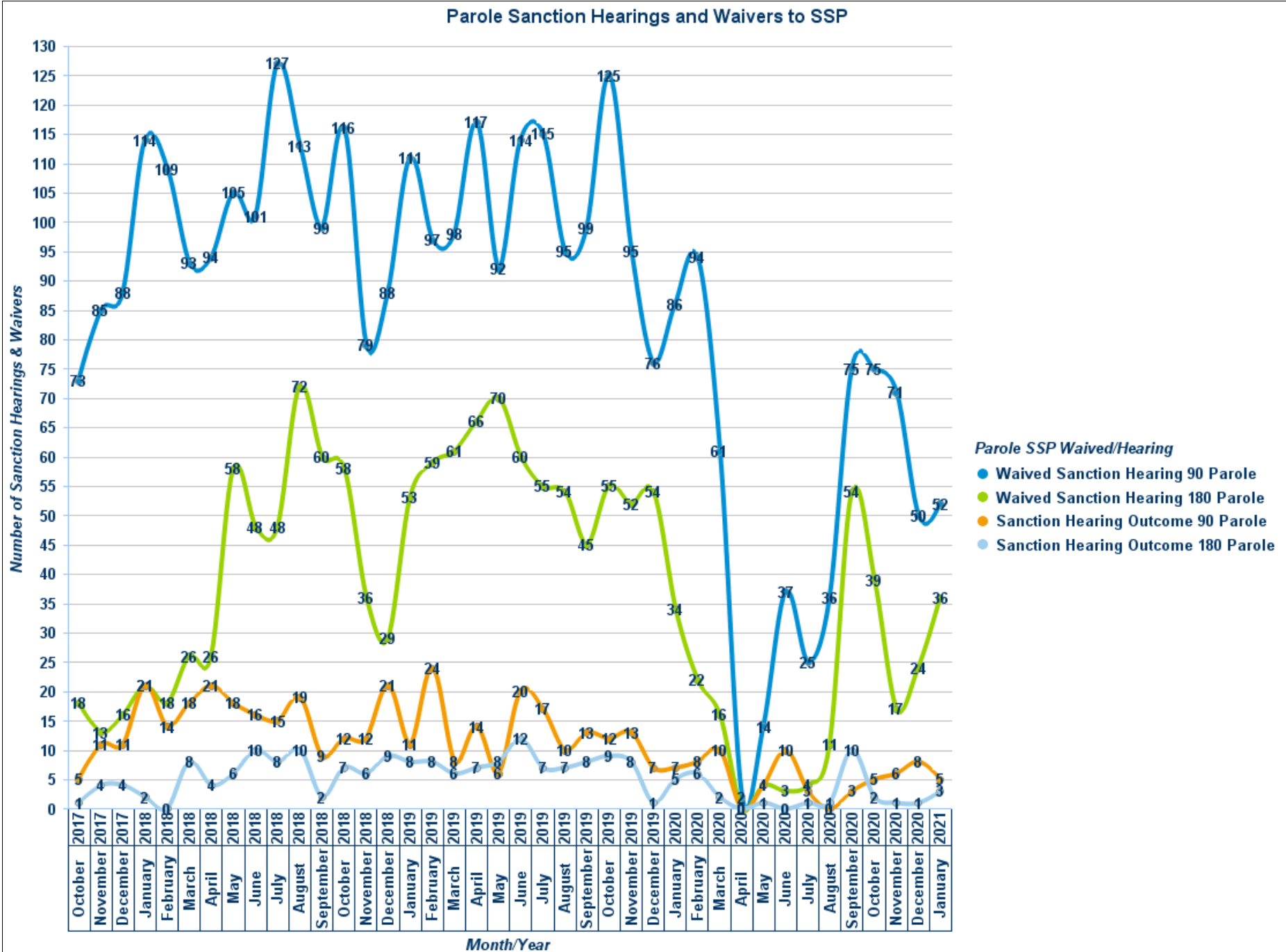
