From the Director

Mountain Home Drug Court (**Area 2**) offender provided snowplow service the Parole and Probation office when the area experienced copious amounts of snow. From the evening of February 14 through February 17, the Mountain Home area received a significant amount of snow and faced temperatures as low as 0 degrees Fahrenheit with highs of about 10 degrees Fahrenheit.



It was extremely cold and roads were treacherous for travel. Agent Nick Mayfield received a call from a Drug Court participant asking if he could clear the parking lot for the Mountain Home office, free of charge. The offender stated that he was out doing the work and, since he already had the equipment, thought he would take care of the office parking lot while he was at it. Agent Mayfield told the offender to not lose time where he could be earning money. Late on the evening of Thursday, February 18, the offender called again and asked if he could clear the office parking lot. Agent Mayfield advised that he could do so if he desired and assured him that he would be recognized for his efforts. The offender advised at around midnight on Friday, February 19, that the lot had been cleared as well as it could be and that the sub-ice would melt when the sun hit it in the morning. This hard-working offender is currently in Phase 4 in the Mountain Home Drug Court Program.

Area 2 Agent Josh Morehead conducted a home visit at the reported residence of two probationers with the assistance of the 16th Judicial District Drug Task Force and Izard County Sheriff's Department and found items of drug paraphernalia and a wood burning stove that had been reported stolen. Both offenders were taken into custody by the Izard County Sheriff.

North Little Rock (**Area 8**) Assistant Area Manager Dr. Debra James (shown below:) spent four hours on a Saturday working as at the COVID-19 Vaccinate the Natural State Clinic in North Little Rock. This clinic was sponsored by Arkansas Blue Cross and Blue Shield in association with the Arkansas Health Department.



Rogers Parole & Probation Officers (**Area 1**) followed up on a lead from the Arkansas State Fusion Center and arrested a probation offender who was in possession of 887 grams of marijuana, scales, baggies, and \$15,267 in cash. The offender will be charged with an enhancement for his narcotics sales due to proximity to a school.



Officers Jimmy Bruce and Amanda Cutler in **Area 4** did a home visit search after a parolee failed to report for an office visit. The picture below shows a gun that was found in the home visit.



Area 5 Manager Wendi Phillips, Assistant Treatment Program Managers Perry Malone and Jodi Howard, Agent Lydia Humphrey, and Advisors Darryl Newton and Christ Burnett met with the Crawford County judge, prosecuting attorney, and public defender's office regarding implementing Medication Assisted Treatment in the Crawford County Drug Court. All parties agreed that MAT would be another great treatment resource for Crawford County Drug Court participants.

Agents with the 2nd Judicial District Drug Task Force along with the Wilson Police Department worked with **Area 4** Parole and Probation officers to conduct a search at the residence in Wilson in Mississippi County. Upon arrival to the residence, it was cleared

for officer safety and a search revealed meth, ecstasy, marijuana, money and a defaced firearm (keltec 9mm carbine). The offender living at the residence was taken into custody.

Area 8 Agent Violet White received information that an offender was involved in the sale of illegal narcotics. With the help of Little Rock police, surveillance was conducted at the residence where the offender lived. He was observed leaving that residence on the way to the parole office for his regularly scheduled office visit and when he arrived at the parole office he was detained and a search of his vehicle was conducted. In the center console of the vehicle Agent White located a single key, which appeared to be a house key. the offender was transported to the residence and a search was conducted and several individually packed containers of marijuana were located, as well as suboxone strips. The scene and all evidence was turned over to the Little Rock Police Department Narcotics Unit, who were granted a search warrant of the property. Four ounces of marijuana, suboxone strips, and \$700 was seized from the residence.

Area 2 Agent Josh Morehead conducted a home visit at the reported residence of two probationers with the assistance of the 16th Judicial District Drug Task Force and Izard County Sheriff's Department and found items of drug paraphernalia and a wood burning stove that had been reported stolen. Both offenders were taken into custody by Izard County Sheriff's Department.

Morehead and Officer Hunter Boles conducted a home visit at the reported residence of a parolee with the assistance of the 16th Judicial District Drug Task Force and Izard County Sheriff's Department and found items of drug paraphernalia. The offender admitted to using one of the items to ingest methamphetamine. He was taken into the custody of Izard County Sheriff's Department and evidence was collected by the task force for processing.

The Northeast Arkansas Reentry Coalition just completed STEPS, a resource directory for those in need in the community. Printed versions will be distributed in places such as ACC parole offices, The HUB Homeless Resource Center and the Jonesboro Goodwill Career Center. The directory also will be placed on the Northeast Arkansas Reentry Coalition website and Good



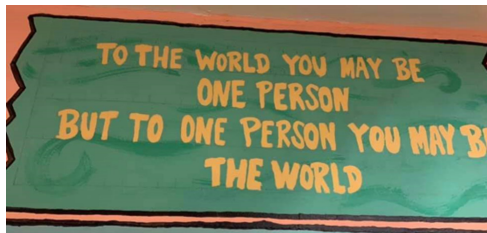

A new Reentry facility has been approved in Jonesboro. In His Wings, a non-profit that is directed by Jennifer Tarwater, will be able to house up to 12 female reentry participants. Tarwater was in the Jonesboro Drug Court program along with spending time in ADC previously. She made it her mission to change her life, fight her addiction, and assist others who are going through addiction and incarceration to turn their lives around. In His Wings has been open for three years and has been successful in assisting women with their addiction and transition time. They were licensed by ACC as reentry in early February.

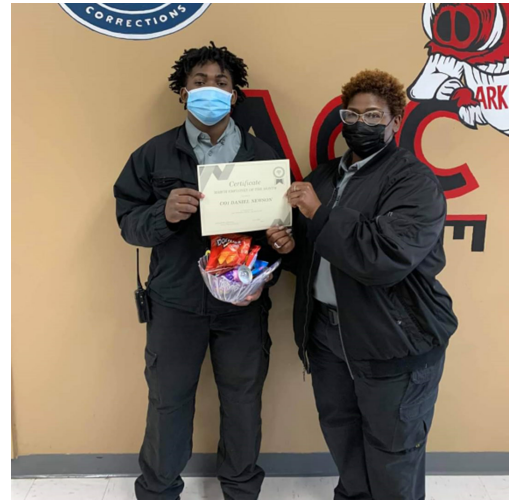

February Treatment Program Summary:

657 probationers and parolees were served in the general Substance Use Disorder Treatment Programs. Additionally 1,050 participants were served in the Drug Court treatment programs, bringing the total served to 1,707. A total of 487 residents have agreed to participate in Medication Assisted Treatment (MAT) since the program started in July 2018; 228 are discharged with follow up in progress in the community; and 52 have completed the program. Partnership is in effect with 59 community providers to continue MAT upon release from the Centers.

General Treatment Program Summary (Non-Drug Court):

Substance use disorder groups: 433 participants
Case management: 59 participants
Continuing care: 156 participants

Domestic violence prevention: 2 participants

Life skills: 15 participants

Tobacco use treatment groups 4 participants

Reentry Facilities:

ACC has 7 licensed reentry facilities with 250 total residents currently in Phase I-IV of the Reentry Facility Program. There was a total of 23 reentry graduates this month.

During February, 45 new residents were transferred into the reentry program, 15 residents started WAGE classes, 6 residents completed WAGE, and 12 residents started the Career Readiness Certificate program (CRC), 11 residents completed CRC and 1 resident started GED classes. A total of 22 reentry facility residents received their driver's license, 29 received an ID card, 27 received their Social Security card and 12 received birth certificates.

Reentry Officers:

Reentry officers reported 5 education referrals that resulted in an education enrollment. Reentry officers conducted 139 reentry facility office visits, 159 Phase IV office visits, 41 Phase IV home visits, and 37 Pre-Parole Plan Verifications.

Transitional Housing:

A total of 22 licensed facilities with 379 ACC funded residents in the facilities.

Within the transitional facilities there are a total of 161 residents who have obtained full time employment, 20 part time employed, 19 receiving disability and 179 pending employment and/or left facility prior to obtaining employment.

This month, 16 residents reported to have enrolled in GED classes, 5 residents started the Career Readiness Certificate program. There is a total of 65 registered sex offenders living in a transitional facility.

A total of 19 residents in transitional housing received their driver's license, 71 received an ID card, 64 received their Social Security card and 29 received birth certificates.

35 residents graduated from the transitional housing program, 32 absconded, and 18 were dismissed.

Specialized: These officers supervise strategically specialized caseloads consisting of offenders requiring heightened supervision protocols (intensive supervision) and parolees who have absconded supervision (Special Response Team).

Indirect: These are offenders for whom their sentence, circumstance, or current status is associated with a reduced supervision obligation for the officers they are assigned to. Generally, these include offenders in non-reporting status, those on suspended sentences (SIS), and interstate compact offenders. Offenders on annual supervision are also included in this group.

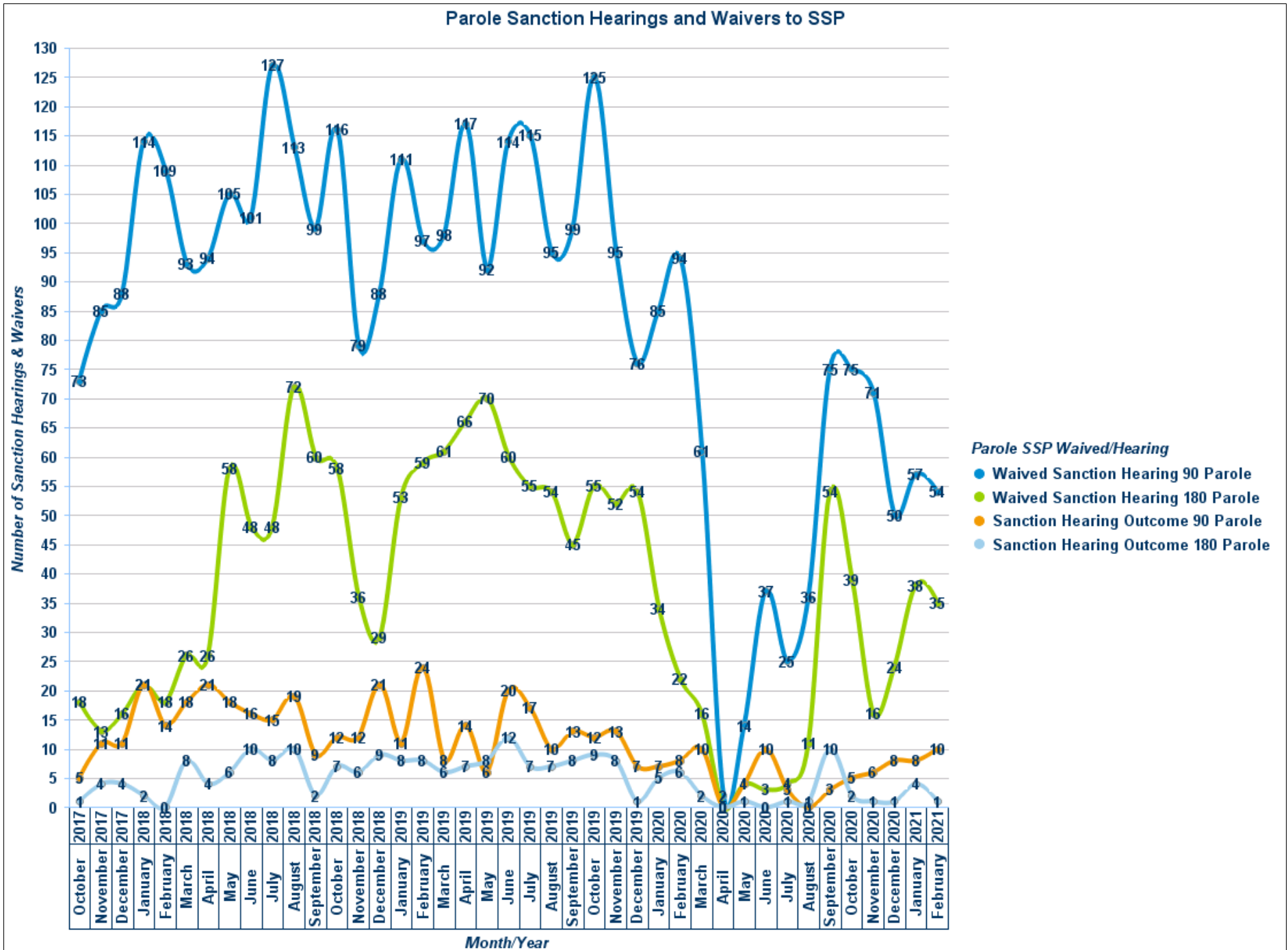
