In early January, Arkansas Division of Community Correction Agents from the Mountain Home Parole and Probation office (**Area 2**) stopped by The Bob Davis Veteran Center in Mountain Home to donate funds and take a tour of the newly opened veteran center. A collection was taken up by ACC staff around Christmas 2021 and the staff donated \$250 to the facility and will receive a spot on the center's Wall of Honor. The Bob Davis Veteran Center is currently going through a soft launch before its grand opening in March and has begun housing struggling veterans in search of work and a better life.

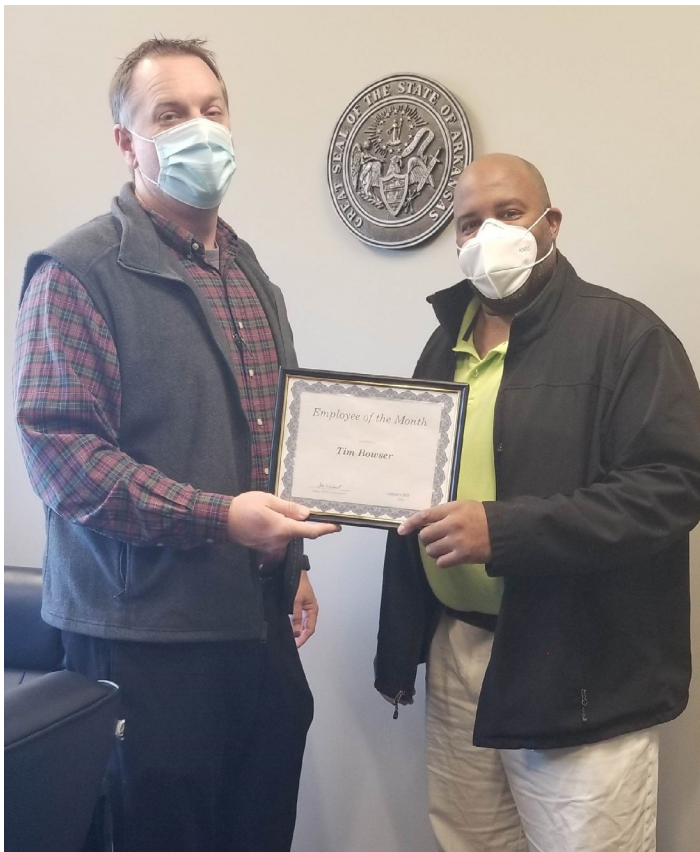

many functions that treatment staff take on during a day working at a center.

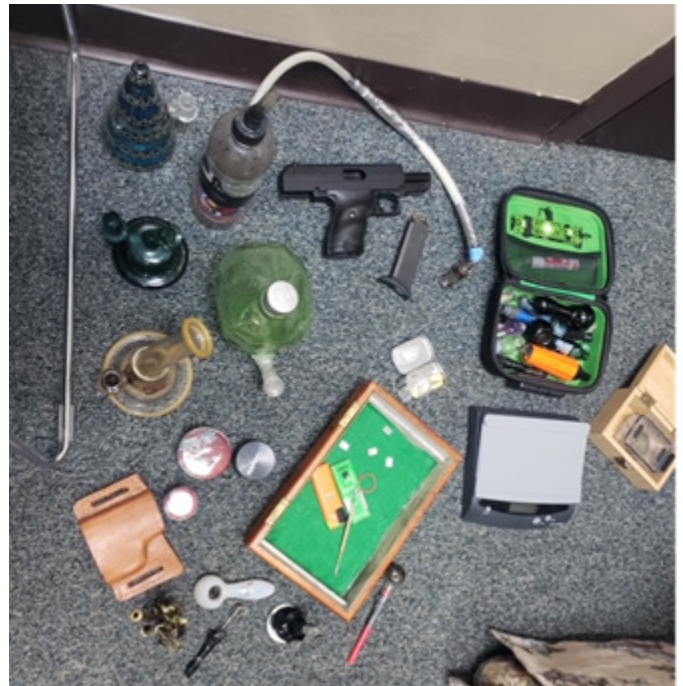


Dalton Barentine (shown below) was promoted to Sergeant, effective in late January, at the Omega Supervision Sanction Center in Malvern.





Area 2 Agent Steve Simers conducted a home visit in Mammoth Spring with the assistance of officers from the Fulton County Sheriff's Department and found drug paraphernalia and a 9 mm pistol. The offender was transported to the Fulton County Detention Center with pending felony charges.

The home visit was conducted after a tip was received that the offender might have multiple firearms in his residence and distributing controlled substances. The tip was accurate and officers found drug paraphernalia and a loaded pistol. All evidence was collected by DTF agents and officers traveled to the offender's worksite and a search of his vehicle yielded several small plastic baggies containing a white crystalline substance believed to be methamphetamine, clown stamps believed to contain LSD, a green leafy substance believed to be marijuana, a substance believed to be heroin, multiple loaded syringes, and other items of drug paraphernalia. All evidence was collected by DTF and the offender was transported to Marion County Detention Center with pending felony charges.

Area 8 Agents Ryan Gordan and LaMarkus Jordan found approximately 12 pounds of marijuana and around 3 ounces of crushed substance that field tested positive for fentanyl in an offender's home. The agents made the home visit after the offender was arrested in the North Little Rock Parole and Probation office on an outstanding warrant. The offender was taken into custody by Little Rock Police and was booked into the Pulaski County Jail on new felony charges.



Treatment:

1,325 parolees and probationers were served in general Substance Use Disorder Treatment programs. Additionally 1,380 participants were served in the

Drug Court Treatment programs, bringing the total served to 2,705.

A total of 573 residents have agreed to participate in Medication Assisted Treatment (MAT) since the program started in July 2018 - 294 are discharged with follow up in progress in the community and 82 have completed the program. Partnership is in effect with 71 community providers to continue MAT upon release from the Centers, and the program has been extended through September 2022 with Peer Recovery Specialist and Transitional Housing services added.

The Intensive Case Management pilot program in Area 8 (North Little Rock Parole and Probation office) which began in September 2021 currently has four participants. There are 14 referrals for services in progress. Activities this month include two assisted with housing; four in ongoing mental health therapy; two assisted with basic needs; and three with employment.

Area 3 Drug Courts in Pocahontas and Walnut Ridge held a joint court session followed by a graduation ceremony at the local historic Powhatan Courthouse in late January. It was reportedly the first time a court session was held in the courthouse in 70 years.

Reentry Facilities:

As of January 31, ACC has seven licensed reentry facilities with 202 total residents currently in Phases I-IV of the Reentry Facility Program. A total of 228 offenders in the Reentry program graduated in January.

During the month, 22 new residents were transferred into the Reentry program, one resident started WAGE classes, two residents completed WAGE, two residents started GED classes, five residents started the Career Readiness Certificate (CRC) program and 11 residents completed CRC. Ten Reentry Facility residents

received their driver's license, seven received an ID card, 10 received their Social Security card and 13 received birth certificates.

Reentry Officers:

In January, 137 Reentry residents were reported to be employed and 18 were reported to be ineligible for employment at this time. Reentry Officers reported eight education referrals resulted in education enrollment. Reentry Officers conducted 177 reentry facility office visits, 155 Phase IV office visits, 39 Phase IV home visits, and 82 pre parole plan verifications. Reentry Officers made 33 community contacts within their assigned area during the month. Reentry officers conducted 70 office visits in their area.

Transitional Housing:

As of January, there are 18 licensed vendor facilities with 389 ACC funded beds.

Within the Transitional Facilities, there are a total of 256 residents who have obtained full time employment. During January, two residents reported to have enrolled in GED Classes. A total of 15 residents received their driver's license, 84 received an ID card, 63 received Social Security cards and 27 received birth certificates.

A total of 46 graduated the transitional housing program, 56 absconded and 18 were dismissed.

There are 35 registered sex offenders living in transitional facilities.

Arkansas Works:

During the month, there were 448 individuals screened for the Arkansas Works program. There were 448 applications received and 761 who enrolled in a qualified health plan, as reported by the Eaton Agency.

Indirect: These are offenders for whom their sentence, circumstance, or current status is associated with a reduced supervision obligation for the officers they are assigned to. Generally, these include offenders in non-reporting status, those on suspended sentences (SIS), and interstate compact offenders. Offenders on annual supervision are also included in this group.

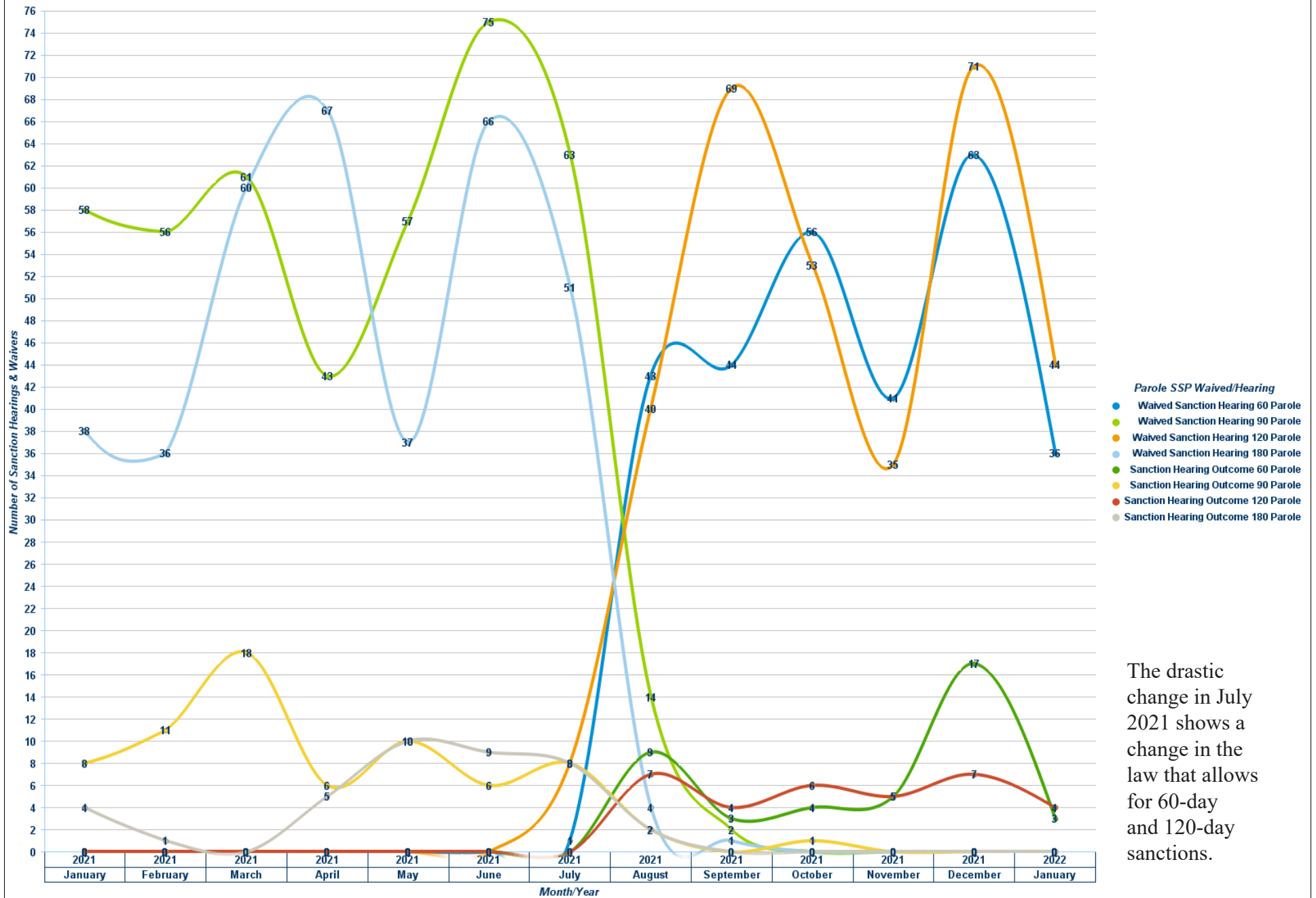
