Area 1 conducted a canned food drive for PPPS Week. The car-load of canned goods were donated to




LifeSource's food pantry in Fayetteville and the First Assembly of God Food Bank in Huntsville.



PAROLE/PROBATION AREA HIGHLIGHTS: AREA 1

During the month, Area 1 staff assisted with Washington County Failure to Appear (FTA) Amnesty Day. Assistant Area Manager Cody Muldrew and Parole/Probation Officer Walter Riketa attended the Amnesty Day at Genesis Church. Any community members with





outstanding FTA warrants could come to Amnesty Day and meet with Public Defenders, Prosecutors, and Probation Officers to get back into compliance. If the case could be settled that day, they went to court in the afternoon and got it cleared up.

AREA 2

On July 25-28, members of the 14th Judicial District Drug Court team had the opportunity to travel to Nashville, Tennessee, for the National Association of Drug Court Professionals (NADCP) conference. Multiple classes were offered that focused on

informing, improving and evolving specialty courts to better treat participants in local drug courts. After attending



hours of classes each day, the team spent time together enjoying food and fellowship while discussing the takeaway information from the day's presentations.

AREA 2, continued:

On July 26, Secretary Solomon Graves visited the Harrison Parole and Probation Office. He was able to observe an intake, visit a session of the Circuit Court and experience several home visits.

AREA 3

Staff from the Parole and Probation Offices collaborated to make generous donations to the toy drive organized by Sex Offender Services. SEX OFFENDER SERVICES (SOS)

On July 14, Sex Offender Services Area Manager Jennifer Dean created a training curriculum regarding human trafficking to be added to the Probation and Parole Academy.

PAROLE/PROBATION HOME VISITS:

On July 8, **Area 2** Agent Hunter Boles, assisted by deputies of the Izard County Sheriff's Department, conducted a home visit at the Melbourne Motel, which was the reported residence of a parolee. In

addition to the parolee, there were three others present at the residence – two of whom were currently under supervision. The compliance check resulted in the discovery of approximately 11 grams of a substance suspected to be methamphetamine as well



as several items of drug paraphernalia. All subjects were taken into the custody of Izard County Sheriff's Department and have been charged with applicable felonies.

On July 28, **Area 2** Agents Bobby Hicks and David Beaty, assisted by investigators with the Baxter County Sheriff's Department, conducted a home visit at the reported residence of a parolee. The compliance check resulted in the discovery of

approximately 75 grams of methamphetamine laced with fentanyl as well as drug paraphernalia. Also discovered were items that had been reported stolen from several vehicle breakins from Norfork, Salesville, Briarcliff and Buford. The offender was taken into the



custody of the Baxter County Sheriff's Department.

On July 7, **Area 4** Agent Andrew Spillman and Officer Ethan McGinnis, along with the Greene County Sheriff's Office, conducted a home visit at

the residence of a probation absconder who had a felony Failure to Appear warrant. Following the offender's arrest, a search of the residence yielded 14



firearms and a large amount of ammunition as well as methamphetamine and paraphernalia.

The same day, Agent Spillman and Officer McGinnis transported a parolee to his residence after he

reported for his office visit under the influence. During a search of the residence, a large amount of methamphetamine, marijuana, and paraphernalia



including scales, baggies and pipes were discovered.

During the month, **Area 11** Agents Douglas Johnson, Dustin Parker, Collin Frierson, Brooke Williams and Officer Anthony Spadoni conducted a home visit/ employment verification after an offender failed to report for a scheduled office visit.

When agents entered the office area of the offenderowned Pine Bluff business, they found a loaded 12-gauge shotgun and, in a desk drawer, a bottle containing pills and a white powdery residue. When the offender arrived, he had \$1,527 in cash, 10 grams of what was later determined to be methamphetamines and a prescription pill bottle

without a label with pills later identified as Alprazolam and Hydrocodone.

A search of the offender's vehicle yielded a .38 special revolver with



live rounds and a 7- to 8-inch knife. The offender was transported to the detention center by the Pine Bluff Police Department and booked on the charges of Possession of a Controlled Substance with Intent to Deliver, Possession of a Firearm by Certain Persons, and Possession of a Controlled Substance.

TREATMENT:

PROGRAM SUMMARY

1,654 probationers and parolees were served in the general Substance Use Disorder Treatment programs.

TREATMENT, continued:

Another 1,465 participants were served in the Drug Court Treatment programs, bringing the total served to 3,119.

A total of 600 residents have agreed to participate in Medication-Assisted Treatment (MAT) since the program started in July 2018. As of July, a total of 366 were discharged with follow up in progress in the community and 96 have completed the program.

Partnerships are in effect with 75 community providers to continue MAT upon release from an ACC center. The grant ends on September 30, 2022. The State Opioids Response (SOR) III grant application has been submitted to the Division of Aging Adult and Behavioral Health Services (DAABHS) for the third cycle of the grant that will continue the MAT program from October 2022 if awarded.

An Intensive Case Management pilot program in the North Little Rock Parole/Probation Office (Area 8) began in September 2021 and currently has four active participants. Activities in July included three referrals to mental health services, two assisted with housing and three with employment.

Drug Court Treatment Program staff across the state attended the National Drug Court Conference in Nashville, Tennessee. Feedback was positive, with the conference presenting relevant topics for reference and continuing education.

General Treatment Program Summary

TREATMENT PROGRAM HIGHLIGHTS

Some of the July Treatment Program highlights included:

Area 1:

• Drug Court programs in Fayetteville, Rogers and Huntsville had a potluck and jointly organized a canned and dry food drive in celebration of Pretrial, Probation and Parole Supervision (PPPS) Week.

Area 2:

- Berryville and Mt. View Drug Court guest speakers addressed resume writing, job applications, interviews, building good credit and college education opportunities.
- The Substance Abuse Program Leader (SAPL) in Mountain Home taught a 3-hour session on opioids at the North Central Unit.

Area 3:

- The participants and Drug Court team volunteered 50 hours at the Recovery Picnic held in Searcy where participants interacted with representatives of other community resources present.
- Batesville Drug Court activities included a guest speaker from a local funeral home presenting a grief education topic, and two peer recovery specialists speaking on the topics of life before and in recovery. A question-and-answer session that followed addressed steps for becoming a peer recovery specialist.

Area 4:

• An Osceola Drug Court graduate spoke to current participants in the program about life in recovery and their experience in the program.

Area 5:

• PPPS Week celebration activities in Clarksville and Fort Smith included a potluck and group session testimonies by participants on their supervision experiences.

Area 6:

• The MAT Program Coordinator attended the Recovery Connection Leadership Group, visited ARCare for a meeting with new staff and conducted visits at ACC Centers with the MAT Substance Abuse Program Leader for a review of consistency in programing.

TREATMENT, continued:

Area 8:

• The Treatment team in North Little Rock won the in-house challenge for the most items collected for the homeless as part of celebration of PPPS Week. The program also welcomed representatives from UAMS, who gave a presentation on HIV, AIDS and other sexually transmitted diseases. The representatives provided free HIV tests to program participants with voluntary participation.

Area 10:

• The Drug Court team in Hot Springs held a cookout for participants and their kids that focused on program awareness, healthy interactions and family unification.

REENTRY PROGRAM:

REENTRY FACILITIES:

As of July 31, ACC had six licensed Reentry Facilities with 204 total residents in Phases I-IV of the Reentry program. Since the program began, a total of 2,634 individuals have successfully completed and graduated from the program. There were 20 reentry graduates during the month.

In July, 35 new residents were transferred into the Reentry program, 16 residents started the Career Readiness Certificate program and five residents completed the program. Eighteen (18) Reentry Facility residents received their drivers license, 17 received an ID card, 14 received their Social Security card and 14 received birth certificates.

REENTRY OFFICERS:

In July, 121 residents were reported to be employed and 33 residents were reported to be ineligible for employment at this time. Reentry Officers reported eight education referrals that resulted in education enrollment.

Reentry Officers conducted 138 Reentry Facility office visits, 114 Phase IV office visits, 22 Phase IV home visits and 46 pre-parole plan verifications. Reentry Officers made 25 community contacts within their assigned area during the month and conducted 107 office visits in their area.

TRANSITIONAL HOUSING:

There are 18 licensed vendor facilities with 549 beds (418 ACC-funded) within the facilities. Within the transitional facilities, there are 266 residents who have obtained full-time employment.

In July, three residents reported enrollment in GED classes and there are 325 Transitional Housing facility residents who reported having previously received their GED or high school diploma.

During the month, there were 47 registered sex offenders living in transitional facilities.

A total of 19 residents received their drivers license, 119 received an ID card, 83 received their Social Security card and 28 received birth certificates.

A total of 73 residents graduated from the Transitional Housing program, 55 absconded and 39 were dismissed.

VOLUNTEER PROGRAM:

In July, there were 421.50 volunteer hours reported from Transitional Housing and Reentry Facilities.

EMPLOYMENT:

During the month, 387 residents reported to have full-time employment within the Reentry and Transitional Housing Facilities.

COMMUNITY AWARENESS:

Arkansas Peer Recovery Program – There are 300 trained peers in the state.

Harbor House, Inc. – Currently, there are 23 recovery coaches trained to work with offenders. There are nine recovery coaches embedded in various locations which include: Sebastian, Johnson, Franklin, Faulkner, Pulaski, Washington, Benton, Garland, Miller, Pope and Logan counties.

Specialized: These officers supervise strategically specialized caseloads consisting of offenders requiring heightened supervision protocols (intensive supervision) and parolees who have absconded supervision (Special Response Team).

Indirect: These are offenders for whom their sentence, circumstance, or current status is associated with a reduced supervision obligation for the officers they are assigned to. Generally, these include offenders in non-reporting status, those on suspended sentences (SIS), and interstate compact offenders. Offenders on annual supervision are also included in this group.


