# FROM THE DIRECTOR: SYRNA BOWERS PROMOTED TO DEPUTY DIRECTOR

Syrna Bowers was promoted to Deputy Director of Residential Services on July 1.

For the past 17 years, she has progressed through the ranks with ACC as an Advisor, Substance Abuse Program Leader, Treatment Supervisor (Southeast AR CCC and East Central AR CCC),



Deputy Warden (Northeast AR CCC), and Warden (East Central AR CCC). In 2016, while managing the relocation of the 350 bed Modified Therapeutic Community Program from Pine Bluff to West Memphis, she was responsible for organizing and coordinating clinical programming and development. Mrs. Bowers was responsible for hiring and developing employees in various departments. She was recognized in 2012 as Treatment Employee of the Year, in 2017 as Treatment Supervisor of the Year and in 2019 as Horizon Award/ Deputy Warden of the Year. Mrs. Bowers learned under the tutelage of retired Wardens Phyllis Silas and Terry Mapes and former Deputy Director Jimmy Banks. She has earned several professional credentials including Certified Law Enforcement Instructor, Certified Clinical Supervisor, Advanced Alcohol Drug Counselor, Collaborative Casework Instructor and Gender-Responsive for Justice Involved Women Instructor. Mrs. Bowers serves as an Executive Board Member to the Arkansas Substance Abuse Certification Board and is an Advisory Board Member for Exodus. She has a Master's Degree in Addiction Studies from the University of Arkansas at Pine Bluff.

I am confident that Mrs. Bowers will lead Residential Services to new heights and continue to improve on the performance of our Community Correction Centers.

#### PASSING OF JAMES T. "JIMMY" BANKS

The Department of
Corrections family withstood
a painful blow on June 30
when Deputy Director of
Residential Services James T.
"Jimmy" Banks III tragically
passed. Mr. Banks was looking
forward to a well-deserved
retirement and was working
to pass the torch and prepare
Syrna Bowers to transition



into the Deputy Director role. It was heartbreaking that he passed away on the day he was scheduled to retire.

Jimmy worked for the Department for many years, starting in September 1985 at the Tucker Maximum Security Unit as a Correctional Officer I. He held many other positions over the years including Deputy Warden and Warden at Varner/Varner Super Max, and Warden/Superintendent at the Tucker, North Central, Delta Regional, and Grimes units. He ended his career as ACC Deputy Director of Residential Services. He was instrumental in the development of our agency, including being present for the groundbreaking of the Supermax Unit at Varner, the initial licensing of the Omega Unit, and the relocation and initial accreditation of the East Central Center in West Memphis.

His legacy will live on through those who will continue the mission he started, transforming our agency into one that not only holds individuals accountable, but also works to instill character and work ethic in the offenders we serve.

His memorial service was held on July 14 at Fellowship Bible Church in Little Rock. He was eulogized by colleagues past and present, including Corrections Secretary Solomon Graves, Board of Corrections Chairman Benny Magness, Parole Board Chairman John Felts, Division of Community Correction Director Jerry Bradshaw and former ADC Director Larry Norris. Mr. Banks left a legacy of service and will be sorely missed.



A total of 27 volunteers spent a combined total of approximately 138 hours preparing for and putting on the event. Volunteer agencies included the Northeast Arkansas Children's Advocacy Center; Jonesboro FOP Lodge #8 Members from the Jonesboro Police Department; Arkansas Department of Corrections, Division of Community Corrections; Craighead County Sheriff's Department and Poinsett County Sheriff's Department.

#### AREA 5

Area 5 officers attended a two-day class by the Drug Enforcement Administration. Students received classroom training on: the 4th Amendment; drug identification and drug trends; safety procedures associated with the handling of fentanyl; field training on shooting in and around vehicles; moving, shooting and communication; positional shooting; hasty response techniques; and 1-2 man clearing of residential buildings.

Masterpiece Ministries of Arkansas is opening a women's group home in the Mena area. One of Area 5's counselors and two former Drug Court participants are on the board. This month, Area 5 community service workers spent time helping



at both the retail store that will help fund the shelter and on upgrades to the shelter itself.

On June 13-22, Agent Danny Marsh participated in a training exercise with the Civil Air Patrol in San Antonio, Texas.

In June, Benton Parole/Probation welcomed Darron Jones to the Benton team as the new Drug Court counselor.

#### AREA 11

On June 16, Capt. John Bean with the Jefferson County Sheriff's Department conducted a training on active shooters at the Pine Bluff Office. All staff were able to attend, and discussions were held on how both law enforcement,



and non-law enforcement staff should handle an active shooter in the office or out in public.

#### **SEX OFFENDER SERVICES (SOS)**

On June 8, Sex Offender Services Area Manager Jennifer Dean Jordan and Area 10 Manager Krystle Williams met with Capt. Scotty Dodd, Garland County Criminal Investigations Division supervisor, and Courtney Kizer, Garland County deputy assigned to Sex Offender Registration.

The meeting was geared toward developing and implementing collaborative strategies between agencies to enhance offender accountability and community safety.

Later in June, Dean Jordan provided information to the Division of Community Corrections Sex Offender Specific Officers and the Sex Offender After Care Program team pertaining to 15 social apps that children might be using.

Sexual predators are known to access such apps to gain access to children with the foresight that many parents are unaware their children are using these social media sites. To make matters worse, some applications are used to hide photos, videos, files, and browser history, placing parents even further "in the dark."

Examples of applications were: "Hot or Not," a social app that encourages users to chat and rate each other's profiles, and "MeetMe," an app that allows users to connect based on geolocation and encourages them to meet up.

#### PAROLE/PROBATION HOME VISITS:

Area 2 (Mountain View) Agents Lisa Wells and Jimmy Carter assisted the 20th Judicial District Drug Task Force in executing a narcotic search warrant in the town of Scotland on June 29. Officers located suspected methamphetamine, marijuana, and drug paraphernalia.

In early June, Area 8 Intensive Supervision Program (ISP) agents received information that an offender was involved in narcotics sales at a hotel and had been observed by undercover Little Rock Police Department (LRPD) units leaving a hotel room and carrying out bags as if checking out, before leaving the hotel and driving to the Parole Office. Upon arrival at the office, the offender was approached by ISP Agents in the parking lot and taken into custody. A vehicle search was conducted and a black bag that had been observed to be with the offender by the undercover officers was located. The bag contained a handgun loaded with one in the chamber, a plastic bag containing marijuana, a digital scale and a small blue container with a white powdery substance inside that was believed to be fentanyl. The offender was transported to the LRPD and charged, and a parole hold was placed.





### **HOME VISITS, continued:**

On June 15, Officer Spadoni and Agent Parker from the Area 11 Office responded to the home of an offender at the request of an officer with the White Hall Police Department. Upon arrival, the offender was in handcuffs in the yard. After identifying the offender's vehicle, a search of it commenced which resulted in Officer Spadoni and Agent Parker locating a glass methamphetamine pipe and a tool bag with a glasses case inside containing two bags of a white powdery substance suspected of being fentanyl. Further searching revealed a catalytic converter that had been removed from a vehicle and a bottle of vodka and whiskey. When Officer Spadoni and Agent Parker moved the search inside the residence, they discovered a loaded revolver in a holster, a crossbow and bow, four glass methamphetamine pipes, eight counterfeit

\$100 bills, a tablet with a white powdery substance on it that was suspected of being methamphetamine, a straw and scales. The evidence was collected by the Pine Bluff Police Department and the offender was taken to the CID for questioning.

#### TREATMENT:

#### **PROGRAM SUMMARY**

1,697 probationers and parolees were served in the general Substance Use Disorder Treatment programs. Additionally, 1,463 participants were served in the Drug Court Treatment programs, bringing the total served to 3,160.

A total of 654 residents have agreed to participate in Medication-Assisted Treatment (MAT) since the program started in July 2018. As of June, a total of 338 were discharged with follow up in progress in the community and 94 have completed the program.

Partnerships are in effect with 75 community providers to continue MAT upon release from an ACC center. The grant ends on September 30, 2022. The State Opioids Response (SOR) III grant application has been submitted to the Division of Aging Adult and Behavioral Health Services (DAABHS) for the third cycle of the grant that will continue the MAT program from October 2022 if awarded.

An Intensive Case Management pilot program in the North Little Rock Parole/Probation Office (Area 8) began in September 2021 and currently has one active participant. A total of four referrals for services are in progress. This month, one was assisted with housing and one with mental health services.

# TREATMENT, continued: TREATMENT PROGRAM HIGHLIGHTS

#### Area 2:

- Drug Court program participants in Berryville assisted with a DOC hiring event on June 17, and on June 24, the participants attended a presentation by Arkansas Cares on the topic of "HIV, AIDS and Other STDs."
- Drug Court participants in Melbourne attended a Community Health Nurse presentation on "Dose of Reality on Opioids."
- The Substance Abuse Program Leader (SAPL) in Searcy gave a three-hour presentation on "Medical Marijuana: Fact or Fiction" at the North Central Unit with about 35 residents participating.
- A representative of the Stone County Extension
   Office presented topics on Estate Planning/Will
   and Resume and Cover Letter Writing on June 7
   and June 21 in the ACC Mt. View Office.

#### Area 3:

- The Assistant Treatment Program Manager (ATPM) for the North Central Region attended the White County 100 Families panel discussion on domestic violence in Searcy. The ATPM also conducted a training on "Understanding Behavior, Human Relations, and Performance" at the PPO Leadership Academy held at DOC Headquarters.
- The Treatment team in Batesville attended the Who's Who Business Expo where they connected with potential resources and returned with various gift items to be used as incentives in the Drug Court and SAPL programs.

#### Area 4:

 A local treatment provider was a guest at the Northeast Regional team's meeting in Jonesboro and spoke on availability, access, and a possible service agreement with the new treatment program in the area.

#### Area 6:

 The Drug Court team and program participants took part in the Green Up Danville Community Service event.

- The ATPM in the West Central Region completed the training of treatment staff on "Seeking Safety," a program that will be implemented in all Area 6 offices.
- Treatment staff met with representatives of Conway Counseling and Wellness to discuss resumption of in-person mental health services in the Russellville Office.

#### Area 10:

• The Treatment team in the Northwest Region gathered for their annual cookout that included wellness, networking, and team-building activities.

#### REENTRY PROGRAM:

#### **REENTRY FACILITIES:**

As of June 30, ACC had six licensed Reentry Facilities with 201 total residents in Phases I-IV of the Reentry Facility program. Since the program began, there have been a total of 2,612 individuals who have successfully completed and graduated from the program. There was a total of 18 reentry graduates this month.

During the month, 38 new residents were transferred into the Reentry program, nine residents started WAGE classes, eight residents completed WAGE and one resident began GED classes. A total of 13 residents started the Career Readiness Certificate program and 12 residents completed the program. A total of 14 Reentry Facility residents received their drivers license, 19 received an ID card, 17 received their Social Security card and ten received birth certificates.

#### **REENTRY OFFICERS:**

In June, 156 residents were reported to be employed and 33 residents were reported to be ineligible for employment at this time. Reentry Officers reported three education referrals that resulted in education enrollment.

Reentry Officers conducted 164 Reentry Facility office visits, 91 Phase IV office visits, 20 Phase IV home visits and 54 pre-parole plan verifications. Reentry Officers made 30 community contacts within their assigned area during the month and conducted 128 office visits in their area.

### **REENTRY, continued:**

#### TRANSITIONAL HOUSING:

There are 18 licensed vendor facilities with 549 beds (418 ACC-funded) within the facilities.

Within the transitional facilities, there are 231 residents who have obtained full-time employment.

In June, three residents reported enrollment in GED classes and there are 247 Transitional Housing facility residents who reported having previously received

their GED or high school diploma.

During the month, there were 40 registered sex offenders living in transitional facilities.

A total of 19 residents received their drivers license, 97 received an ID card, 84 received their Social Security card and 24 received birth certificates.

A total of 44 residents graduated from the Transitional Housing program, 30 absconded and 26 were dismissed.

**Specialized:** These officers supervise strategically specialized caseloads consisting of offenders requiring heightened supervision protocols (intensive supervision) and parolees who have absconded supervision (Special Response Team).

**Indirect:** These are offenders for whom their sentence, circumstance, or current status is associated with a reduced supervision obligation for the officers they are assigned to. Generally, these include offenders in non-reporting status, those on suspended sentences (SIS), and interstate compact offenders. Offenders on annual supervision are also included in this group.


