PAROLE/PROBATION AREA HIGHLIGHTS:

AREA 1

Ten staff members from Area 1 Parole and Probation took part in a large-scale, Sex Offender Compliance Operation in Benton County on August 23-25. Agents with the U.S. Marshals Service Unit in conjunction with the Benton County Prosecuting Attorney's office led the operation, which was conducted by a multijurisdictional team that also included staff from area police departments from Bella Vista, Cave Springs, Centerton, Decatur, Gentry, Gravette, Pea Ridge, Rogers, Siloam Springs, Springdale and Sulphur Springs, as well as the Benton County Sheriff's Department and the Federal Bureau of Investigation.

On August 23, teams from the participating agencies began conducting early morning consent searches at each registered sex offender's residence. The home visits ensured proper verification as required by Arkansas state law as well as to enhance community safety endeavors. Targets included about 500 registered sex offenders in Benton County with an emphasis on moderate-to high-risk sex offenders.

During the operation, Agents conducted digital on-scene forensic triages of multiple computers, cellular phones, digital storage data devices and tablets. Agents confiscated 26 cellular devices and eight firearms. A total of 44 people were arrested during the operation and charged with various offenses, including firearm possession, drug possession and failure to comply with registration requirements.

AREA HIGHLIGHTS, continued:

Multiple federal and state investigations are being opened as a result of this operation.

As a follow up later in the month, ACC staff conducted compliance checks on sex offenders who were not contacted during the operation due to time constraints. Of those who were verified, an 89% compliance rate was reported. Additionally, ACC staff located 27 of the 51 sexual offenders listed as delinquent with the Arkansas Crime Information Center (ACIC), with notifications made. Sex Offender Services Area Manager Jennifer Dean Jordan contacted the local law enforcement agencies

within the jurisdictions of the delinquent offenders to ensure warrants are



issued for Failure to Comply, as applicable.

AREA 3

Area Manager Tiffany Jackson participated in the Human Trafficking Special Victims Methodology training course. Held at the North Little Rock Justice Center, this was the first time for the class to be offered in Arkansas.

AREA 4


Area 4 Parole and Probation Agents Ashley Stuart and Kristy Gardner participated in the Car-Mart Community Appreciation Event in Jonesboro on August 20. The Agents assisted with teaching



children about gun safety at the Jonesboro Fraternal Order of Police Lodge #8 inflatable Shooting Education Range. During the event, approximately 80 children were provided with a list of gun safety rules and got to shoot BB guns inside the inflatable range.

AREA 5

During August, ACC and the Division of Workforce Services collaborated to provide employment assistance in Logan County. CPPS Paula Cox and Workforce Specialist Brian Hedrick assisted with resumes, interview skills and navigating employment sites on the internet.

AREA 6

On August 3, Officers Heike McKinney and Evan Thomas served as instructors for a CPR class for Area 6 Officers held at the Conway Office.





AREA 8

Congratulations to Violet White of the Intensive Supervision Parole and Probation team for being selected by her peers as Employee of the Month for August. A couple of the reasons her co-workers gave for selecting Ms. White included her willingness to always help out and demonstrating leadership on her team.

AREA 9

During August, a large-scale multijurisdictional team of law enforcement agents conducted a Sex Offender Compliance Operation in Crittenden County over a period of three days. The operation was organized and conducted at the request of State Prosecuting Attorney Keith L. Chrestman. Agents with the Division of Community Correction's Sex Offender Services Unit led the operation, which consisted of agents from nearly a dozen agencies, including: Arkansas Fusion Center, Arkansas Attorney General's Office Cyber Crimes Unit, ACC Special Response Team and Probation and Parole Areas 4 and 9, Arkansas National Guard, Crittenden County Sheriff's Office, Human Trafficking Training Center, Jonesboro Police Department Internet Crimes Against Children Unit, Marion Police Department, National Child Protection Task Force, Second Judicial District Drug Task Force, West Memphis Police Department (including the West Memphis Violent Crimes Suppression Unit) and the U.S. Marshals Service.

On August 8, comprehensive law enforcement teams from the participating agencies began conducting early morning consent searches



at each registered sex offender's residence. The visits ensured proper verification as required by Arkansas state law and enhanced community safety endeavors. Targets included 214 registered sex offenders in Crittenden County with an emphasis on those determined to be moderate to high-risk.

During the operation, Agents conducted digital onscene forensic triages of more than 35 computers, cellular phones, digital storage data devices and tablets. Additionally, Agents confiscated at least ten cellular devices, five computers, and six USB storage devices and executed multiple search warrants for unregistered social media accounts.

Agents arrested 14 people during the operation. Those arrested were charged with various offenses, including possession of child sexual material, firearm possession,

drug possession, and failure to comply with registration requirements. One person – a level 3 sex offender – was arrested for residing within 2,000 feet of a school.

AREA 10

On August 15, Parole and Probation Officers Jennifer Starkey and Mendy Johns spoke to the Think Legacy class at the Ouachita River Correctional Unit.



With great sorrow, Area 10 staff mourn the loss of Assistant Area Manager Sidra Porchia from the Camden Parole/Probation Office. Ms. Porchia passed away on August 22 and was well respected by her peers. She will be forever missed by all who knew her.



PAROLE/PROBATION HOME VISITS:

On August 25, **Area 4** Parole and Probation Agents Bryan Hook, Ashley Stuart, Cameron Sailor and Michael Hopkins conducted a home visit in Jonesboro, with assistance from the Jonesboro Police Department. The effort led to the seizure of 19 firearms, 64.19 grams of methamphetamine, drug paraphernalia and a bullet proof vest. An active supervision parolee and another individual who was present at the residence during the time of the search were both arrested and charged with multiple felonies.



HOME VISITS, continued:

In early August, Area 8 ISP officers received information that an offender was staying at a Little Rock hotel. Upon arrival, officers made contact with a female who was noticeably pregnant and under the influence. The offender was not present, but his belongings were in the room. A search was conducted, and officers recovered a baggie of marijuana, scales, baggies, MDMA pills and an unknown white powdery substance. Further checking revealed that the female was wanted for escape out of Washington state. The female was transported to the Pulaski County Jail on her warrant and charged with Possession of Controlled Substances Schedule I, II with Intent, Possession of Controlled Substances Schedule VI with Intent, Maintaining a Drug Premises, Unauthorized Use of Property to Facilitate Crime, Possession of Drug Paraphernalia and Distribution of Controlled Substances Near Certain Facilities. Warrants will be issued for the offender for the same offenses.

Area 10 Agents Vanessa Townsend and Richard Perry conducted a home visit on an offender, where they discovered guns and drug paraphernalia.



During the month, **Area 11** Agents Dustin Parker and Brooke Williams requested the assistance of ISP Agent Doug Johnson and Officer Anthony Spadoni in an attempt to bring a probation and parole absconder back under supervision. The Agents went to the offender's previous listed address in Pine Bluff, where he answered the door. Agents found a set of digital scales with a small baggie of white

powdery substance (believed to be fentanyl), a pill bottle with a green leafy substance (suspected of being marijuana) and two Narcan kits. The drug task force was contacted and further searching revealed more drugs and paraphernalia. During the



home search, it was noted that the offender became glassy eyed and had trouble staying awake. He admitted to using what was on the digital scales, which was fentanyl, and an ambulance was dispatched to the scene. The offender stated to paramedics that he had consumed "some bars" (Xanax), hydrocodone, oxycodone/oxycontin and fentanyl. He was transported to Jefferson Regional Medical Center and Agents advised that he was to report to the Pine Bluff office immediately upon his release from the hospital. In





all, 10.2 grams of marijuana, 12.3 grams of cocaine, 26.4 grams of crack cocaine, 2.5 grams of heroin, nine hydrocodone pills, three alazopram pills, 22 klonopine pills and 15 oxycontin pills were found in the residence.

On August 17, **Area 11** Agent Dustin Parker and ISP Officer Anthony Spadoni conducted a home visit/compliance check at an offender's residence in Rison.

During the check, Agent Parker located a 5.56 MM Diamond Back Firearms AR-15. The Cleveland County Sheriff's Department



was called, and a Deputy collected the evidence and transported the offender to the county jail where he was questioned and booked.

RESIDENTIAL SERVICES:

CENTRAL ARKANSAS COMMUNITY CORRECTION CENTER (CACCC)

Krystal Neal, an Advisor with CACCC, presented a lecture on parenting during a Treatment Supervisor's meeting held at Central Office in August.

TREATMENT:

PROGRAM SUMMARY

1,616 probationers and parolees were served in the general Substance Use Disorder Treatment programs. Another 1,492 participants were served in the Drug Court Treatment programs, bringing the total served to 3,108.

A total of 679 residents have agreed to participate in Medication-Assisted Treatment (MAT) since the program started in July 2018. As of July, a total of 375 were discharged with follow up in progress in the community and 100 have completed the program.

Partnerships are in effect with 75 community providers to continue MAT upon release from an ACC center. The grant ends on September 30, 2022. The State Opioids Response (SOR) III grant application has been submitted to the Division of Aging Adult and Behavioral Health Services (DAABHS) for the third cycle of the grant that will continue the MAT program from October 2022 if awarded.

An Intensive Case Management pilot program in the North Little Rock Parole/Probation Office (Area 8) began in September 2021 and currently has four active participants. Activities in August included three referrals to mental health services, two were assisted with housing and three with employment.

In August, the Assistant Treatment Program Manager for the Southeast Treatment Region facilitated Motivational Interviewing training at the PPO Academy at DOC Headquarters.

TREATMENT PROGRAM HIGHLIGHTS

Some August Treatment Program highlights included:

Area 2:

- A Berryville Drug Court graduate returned as guest speaker and discussed *Graduating Drug Court* and *Life After Drug Court*. She emphasized the importance of continuing recovery community engagement that includes AA/NA participation. Also in Berryville, a representative of the North Arkansas Community College gave a presentation on True Colors and guided participants on the understanding of self and behaviors.
- A Substance Abuse Program Leader in Mountain Home volunteered to facilitate a three-hour substance use disorder treatment class at the North Central Unit, and in a separate event, led a candlelight vigil in acknowledgment of International Overdose Awareness Day.
- Mountain View Drug Court participants received commendation from other agencies and merchants at the Stone County Health and Education Fair for their assistance with the set up and activities at the event. The fair provided school supplies and health/education needs to school age and the elderly in the community.

Area 3:

 Treatment staff in Batesville visited New Hope Refuge at the facility's invitation and toured the program as part of community networking. The faith-based program for women is located in Bethesda.

TREATMENT, continued:

 A Substance Abuse Program Leader in Clinton invited a guest speaker from Ozark Opportunity Center to speak with program participants.
 Topics included rent, childcare, utility, medical, and other low income family assistance. The presenter provided application forms and the overall response was well received.

Area 6:

 The Assistant Treatment Program Manager and Medication Assisted Treatment (MAT) Coordinator hosted AFMC on their grant required site visit review of the MAT Program. ATPM also attended the local community Recovery Connections meeting, and conducted a training on Drug Court roles and responsibilities with program staff.

REENTRY PROGRAM:

REENTRY FACILITIES:

As of August 31, ACC had six licensed Reentry Facilities with 222 total residents in Phases I-IV of the Reentry program. Since the program began, a total of 2,664 individuals have successfully completed and graduated from the program. There were 28 reentry graduates during the month.

In August, 33 new residents were transferred into the Reentry program, 18 residents started the Career Readiness Certificate program and 17 residents completed the program. A total of 25 Reentry Facility residents received their drivers license, 21 received an ID card, 19 received their Social Security card and 11 received birth certificates.

REENTRY OFFICERS:

In August, 163 residents were reported to be employed and 18 residents were reported to be ineligible for employment at this time. Reentry Officers reported four education referrals that resulted in education enrollment.

Reentry Officers conducted 161 Reentry Facility office visits, 134 Phase IV office visits, 26 Phase IV home visits and 50 pre-parole plan verifications. Reentry Officers made 22 community contacts within

their assigned area during the month and conducted 57 office visits in their area.

TRANSITIONAL HOUSING:

There are 18 licensed vendor facilities with 549 beds (418 ACC-funded) within the facilities.

Within the transitional facilities, there are 355 residents who have obtained full-time employment.

In August, two residents reported enrollment in GED classes and there are 330 Transitional Housing facility residents who reported having previously received their GED or high school diploma.

During the month, there were 52 registered sex offenders living in transitional facilities.

A total of 26 residents received their drivers license, 120 received an ID card, 124 received their Social Security card and 24 received birth certificates.

A total of 64 residents graduated from the Transitional Housing program, 48 absconded and 20 were dismissed.

VOLUNTEER PROGRAM:

In August, there were 788.05 volunteer hours reported from Transitional Housing and Reentry Facilities.

EMPLOYMENT:

During the month, 518 residents reported to have full-time employment within the Reentry and Transitional Housing Facilities.

ARKANSAS WORKS:

During the month, there was a total of 183 individuals screened for the Arkansas Works program. A total of 716 applications were received and 602 enrolled in a "Qualified Health Plan" as reported by the Eaton Agency. In January 2022–August 2022, Qualified Health Plans enrolled 37,834.

Specialized: These officers supervise strategically specialized caseloads consisting of offenders requiring heightened supervision protocols (intensive supervision) and parolees who have absconded supervision (Special Response Team).

Indirect: These are offenders for whom their sentence, circumstance, or current status is associated with a reduced supervision obligation for the officers they are assigned to. Generally, these include offenders in non-reporting status, those on suspended sentences (SIS), and interstate compact offenders. Offenders on annual supervision are also included in this group.


