SEX OFFENDER SERVICES' 2022 HALLOWEEN ENFORCEMENT EFFORTS

Halloween 2022 demonstrated that each area has continued an aggressive approach regarding public safety with a double-down emphasis to ensure the safety of the most vulnerable during Halloween. A total of 1,643 sex offenders were placed under Halloween restrictions.

The approved operational plan to ensure each of the 1,643 sex offenders complied with Halloween restrictions consisted of lock-ins, home detention and approved work permits.

Each office opened its doors from 5:30 p.m. to 9 p.m. to ensure accountability of those ordered to report. Offenders deemed highest risk were subject to report to lock-ins.



Sexual offenders subject to home detention included sexual offenders with notable identified risks: minor victim(s); stranger victim(s); impulse control deficits; abuse of a position of trust or authority, or use of substances in the commission of their sexual offense.

HALLOWEEN 2022, continued:

Allowances were made for those with verified work requirements and/or medical ailments which prohibited in-person reporting. Female offenders were ordered to home detention as to not mix with the opposite sex.

There were 53 technical violations regarding Halloween lock-ins or issues found on home visits. The most common violation was failing to report to lock-in as directed. For those sex offenders that could not be cleared quickly, Area Managers deployed Agents/Officer to locate sexual offenders in the field. This reflects a 97% compliance rate overall.

During the month of October, Career Planning Placement Specialist Bertha Kitchens visited with several local employers to discuss job openings, hiring processes, and the upcoming job fair to be held at the Parole and Probation Office. Employers visited included Vexus Boats, Bass Cat, ASG, Arkansas Plastics, Triton Boats, and Great Escapes RV Center.

AREA 3

On October 25, the White County Drug Court was evaluated, audited, and started a certification process. The evaluation team, which was headed by Dr. Tabrina Bratton, PhD from DOC Shared Services, started out at the Searcy Office and then attended Drug Court. The team asked questions, went through our policies and procedures, and observed court. The audit and certification were conducted by retired Circuit Judge Ralph Wilson, retired Circuit Judge Gary Arnold, and AOC Specialty Court Coordinator Janet Hawley.

On October 26, the White County Drug Court was invited to speak at the 100 Families Alliance meeting. Parole/Probation Agent Rodrigo Almeida, Advisor Susan Hathcote, Drug Court Administrative Specialist Ragina Rains, and a Drug Court participant and a Drug Court graduate were the speakers. The Drug Court participant and graduate discussed their personal experiences in the program and the impact in their lives, families, and society. A total of 85 people from different agencies and two different states attended the presentation.

AREA 4

During the week of September 26, multiple Division of Community Correction employees along with Officers from various local Law Enforcement




AREA 6

They distributed medication lock boxes and gift bags with information on opioid addiction to individuals who brought in unused medications.



PAROLE/PROBATION HOME VISITS:

On October 25, **Area 2** Agent Hunter Boles, assisted by officers from the Izard County Sheriff's Department and Arkansas Game and Fish Commission, performed a home visit at the residence of an offender. Although no contact was made with anyone at the residence, officers discovered three firearms, a stolen motorcycle, and two stolen ATVs outside of the residence.





On October 19, **Area 8** Intensive Supervision Program Agents conducted a visit at the home of an offender. In

addition to a loaded Glock handgun and an AK-47 pistol, Agents located a backpack that contained marijuana, fentanyl pills and white powder. The scene was turned over to Narcotics Officers from the Little Rock Police Department who obtained a search warrant and seized a total of 1.5 pounds of marijuana, 22 grams of cocaine, 26 grams of fentanyl powder and approximately 100 fentanyl pills, along with the weapons. The offender was charged with Trafficking Fentanyl, Possession of Controlled Substance Cocaine with





Purpose, Possession of Firearm by Certain Person, Simultaneous Possession of Drugs and Firearm, Maintaining a Drug Premises, Proximity to Certain Facilities, Possession of Drug Paraphernalia, and Possession of Marijuana with Purpose.

HOME VISITS, continued:

On October 4, **Area 11** Agent Dustin Parker of the Pine Bluff Parole/Probation office and Lt. Trey Gerard and Deputy Josh Bolin of the Cleveland County Sheriff's Department conducted a search of an offender's home. Agent Parker found a glass methamphetamine pipe and a small plastic container with a baggie of methamphetamine, as well as a plastic marijuana pipe and four syringes. Agent Parker also found a 7.62mm Russian-made SKS assault rifle with a fully loaded 30 round clip and one in the chamber. The offender was booked into the Cleveland County Jail for Simultaneous Possession of Drugs and Firearms, Possession of a Firearm by Certain Persons and Felony Possession of Methamphetamines.

TREATMENT:

PROGRAM SUMMARY

1,613 probationers and parolees were served in the general Substance Use Disorder Treatment programs. Another 1,568 participants were served in the Drug Court Treatment programs, bringing the total served to 3,181 for the month.

A total of 718 residents have agreed to participate in Medication-Assisted Treatment (MAT) since the program started in July 2018. A total of 393 were discharged with follow up in the community in progress and 105 have completed the program.

Partnerships are in effect with 77 community providers to continue MAT upon release from an ACC center. The grant ended on September 30, 2022. The State Opioids Response (SOR) III grant award from the Division of Aging Adult and Behavioral Health Services (DAABHS) is pending for the third cycle of the grant that allows continuation of the MAT program as of October 2022. At this time, the anticipated funds release date is November or December.

An Intensive Case Management pilot program in the North Little Rock Parole/Probation Office (Area 8) began in September 2021 and currently has three

active participants. Activities in October included three referrals to mental health services, one was assisted with housing and two with basic needs.

The Assistant Treatment Program Manager from the North-Central treatment region taught a Motivational Interviewing class at the Probation and Parole Academy during the month. Other trainings with treatment staff participation included the Arkansas Prescription Drug Summit presented in person in Hot Springs by the Attorney General's Office and the National Association of Drug Court Professionals (NADCP) virtual training for Regional Treatment Providers.


REENTRY PROGRAM:

REENTRY FACILITIES:

As of October 31, ACC had six licensed Reentry Facilities with 189 total residents in Phases I-IV of the Reentry program. Since the program began, a total of 2,714 individuals have successfully completed and graduated from the program. There were 19 reentry graduates during the month.

During the month, 21 new residents were transferred into the Reentry program, 13 residents started the Career Readiness Certificate program and seven residents completed the program. A total of 20 Reentry Facility residents received their driver's license, ten received an ID card, 18 received their Social Security card and 12 received birth certificates.

REENTRY OFFICERS:

In October, 151 Reentry residents were reported to be employed and 22 residents were reported to be ineligible for employment at this time. Reentry Officers reported five education referrals that resulted in education enrollment.

Reentry Officers conducted 157 reentry facility office visits, 110 Phase IV office visits, 17 Phase IV home visits and 42 pre-parole plan verifications. Reentry Officers made 25 community contacts within their assigned area during the month and conducted 83 office visits in their area.

TRANSITIONAL HOUSING:

There are 18 licensed vendor facilities with 549 beds (430 ACC-funded) in the facilities.

Within the transitional facilities, there are 298 residents who have obtained full-time employment.

In October, four residents reported to have enrolled in GED classes and there are 320 Transitional Housing facility residents who previously received their GED or high school diploma.

During the month, there were 54 registered sex offenders living in transitional facilities.

A total of 44 residents received their driver's license, 199 received an ID card, 181 received their Social Security card and 34 received birth certificates.

A total of 71 residents graduated from the Transitional Housing program, 50 absconded and 20 were dismissed.

Indirect: These are offenders for whom their sentence, circumstance, or current status is associated with a reduced supervision obligation for the officers they are assigned to. Generally, these include offenders in non-reporting status, those on suspended sentences (SIS), and interstate compact offenders. Offenders on annual supervision are also included in this group.


