## Commission Meeting May 31, 2023

Judge Gordon McCain declared that a quorum was present and called the meeting to order. Everyone present was provided an opportunity for photographs by Manda Bass, DOC communications. Judge McCain introduced Secretary Profiri, and attendees made brief introductions.

Judge Blatt moved and Mr. Rutledge seconded the motion to approve the minutes from the December 2022 meeting. The motion was approved unanimously.

Mr. Robbins moved and Judge Jones seconded the motion to approve the quarterly expense report. The motion was approved unanimously.

The Commission was presented with the Population Monitoring report. The population is growing close to the rate anticipated in earlier projections. New population projections are expected from JFA later this year and will likely be presented at the 4<sup>th</sup> quarter commission meeting. The Board of Corrections recently voted to make more beds available to ease the county jail back-up. The total population as of this date is 18,294, which includes approximately 16,000 in ADC facilities and 2,000 in county jail back-up. The Department is actively working to procure property for building a new facility to increase capacity and relieve the county jail back-up. The goal is to have that project complete in the next three years.

Director Tawnie Rowell presented the Time Computation Report for the fourth quarter of 2022. The Time Computation Report is prepared in accordance with the DOC Secretarial Directive and contains the statistical results of the commission staff's review of time entry.

The commission was presented with the contract with JFA for population projections. The cost of the renewal of the contract for this year is split between the Sentencing Commission, ADC, and ACC. Mr. Rutledge moved and Judge Blatt seconded the motion to approve the contract. The motion was approved unanimously.

In preparation for considering the Seriousness Level rankings for new, modified, and omitted offenses, Ms. Rowell advised that at the 2021 rankings meeting, the method for conducting the vote for ranking offenses was to utilize a batch method. Offenses with different conduct provisions but under the same statute were separately ranked but grouped together for discussion and vote. Mr. Robbins moved and Judge Jones seconded to proceed with the batch method for ranking offenses.

The Commission considered rankings for new, modified, and omitted offenses. Attached Tables A, B, and C detail the results of this consideration. All votes were unanimous unless otherwise noted in the table.

Ms. Rowell presented the Director's report. Commission staff submitted 38 Impact Assessments during this legislative session. Several more were drafted but not submitted due to the bill being held or time constraints late in the session. Training was recently provided in Polk County, and an upcoming training is set for Fayetteville, the Pope County Bar Association, and the Arkansas Prosecutors Coordinators Conference.

The commissioners will be provided reports from three committees in the coming months: the Sentencing Order Revision Committee, Time Computation Review Committee, and the Recidivism Reduction Task Force created by the Protect Act. The National Association of Sentencing Commissions 2023 conference will be held in Nevada at Lake Tahoe. Ms. Rowell discussed the portions of the Protect Act relevant to the commission: technical corrections, changes to parole eligibility, and the application of earned release credits. The Department is in the process of drafting rules for these changes as they will go into effect on January 1, 2025. All three of the Commission's bills from our legislative package were included in the Protect Act. The commission has some new statutory duties from the Protect Act and those will be further discussed at the next meeting.

Ms. Rowell highlighted few other legislative pieces of note. Legislation was passed concerning prior residential burglary convictions and the application of parole eligibility statutes. Secretary Profiri has asked for AG opinion on the application so policy decisions can be made on the front end before the effective date of the new laws. Additionally, the Safer Arkansas Act will require DOC & Parole board to publish information online in one spot and develop an app for providing this information to the public.

A discussion was held concerning the next meeting. Judge Jones moved and Mr. Smith seconded a motion to hold the next meeting by Zoom at 8:30 a.m. on July 19, 2023.

The next meeting will be on July 19, 2023, at 8:30 a.m. and will be held via Zoom.

Meeting adjourned.
