COMMUNICATIONS:

During the week of Thanksgiving, the Tucker Unit Farm was presented the Century Farm designation by the Arkansas Agriculture Department, an honor bestowed upon the Cummins Unit in 2022. Communications submitted the detailed application in May. To be considered, a farm must consist of at least 10 acres and have been in continuous operation for at least 100 years. The Tucker Farm began in 1914. Communications also learned that its applications to Arkansas Heritage had received hearings before the State Review Board. The

applications request that the Cummins and Tucker State Farms be declared official Historic Districts of the State of Arkansas, honorary but significant designations. The application process was lengthy and included site visits. The Cummins State Farm hearing was held in December and resulted in a unanimous decision to declare the site an Historic District. The hearing on the Tucker State Farm will be held in April, along with hearings to consider nominating the Tucker and Cummins chapels on the National Register of Historic Places.

Also in December, the Communications Team fielded 178 constituent emails and 56 constituent phone calls. During the month of December, 4,764 ADC and 417 DCC visitation appointments were scheduled for a total of 5,181 appointments.

PROCUREMENT UPDATE

In December 2023, Purchase Orders and Contracts in excess of \$10,000 amounted to \$7,958,825.01, broken down as follows:

• Division of Correction: \$6,878,087.13

• Division of Community Correction: \$478,061.60

• Shared Services: \$602,676.28

Of the total, \$5,222,374.19 was for Inmate/Resident Care and Custody-related items (food, shoes, clothing, etc.). A detailed chart is available on pages 9-10.
