# COMMUNITY SUPERVISION AREA HIGHLIGHTS:

#### AREA 1

On 1-21-2025 Agent Foreman with DEA assistance seized

#### AREA 2

Career Planning & Placement Specialist Bertha Kitchens attended the bi-monthly Unified Community Resource Council Meeting on November 20, 2024, where the speaker was Chris Kellem, WIOA Career Advisor. Some time later, CPPS Kitchens met with Ms. Kellem to discuss the programs that WIOA offers and how they could be of assistance to individuals supervised by the Division of Community Correction. As a result, eligible individuals are referred to Ms. Kellem. Two participants obtained employment through the WIOA program in January 2024.

#### AREA 4

#### AREA 5

#### AREA 6

On 01/21/2025, Perry County Drug Court welcomed the Canine Companions for Justice to speak about their program.

Roxy and Reinhold were welcomed with open arms.



#### **AREA 7/8**

On 1/22/25, ISP received information that offender Braylon Sisk was involved in possible narcotics distribution at 3510 S. Bryant. ISP Agents as well as LRPD narcotics made contact with Sisk and entry was made into the apartment. In plain view on the couch a bank bag was open with marijuana, cash and plastic baggies with a white powdery substance was found. A black laptop bag was on the floor and a 40-caliber pistol was located. A search warrant was requested and executed by LRPD narcotics unit as well as all evidence obtained. Sisk had clothes, paperwork, and assorted items that belonged to him in the bedroom. Anglee Jones was in the apartment as well and was arrested on a warrant out of LRPD. Both Jones and Sisk were transported to the northwest substation for questioning.

#### **AREA HIGHLIGHTS, continued:**

#### AREA 9

On 01/27/2025 - Area 5 CSOs worked together for the extradition of sex offender Bobby Williams ADC 138530 from McIntosh County Jail in Oklahoma and Area 9 transported Gregory Aparicion ADC153453. They met in Mena, AR and exchanged offenders. Great Team work in this effort.

#### AREA 10

01/30/2025: CSA Christine Zimmerman and CSA Tiffani Childers conducted a vehicle search at the Malvern Parole office on offender Allison Allen. During search a small bag with multiple pills were located inside Allen's purse. Malvern PD Officer O'Keefe arrived at the office. The pills were identified as (25 pills) Pregabalin, Schedule 5 and (9 pills) Tramadol. Officer O'Keefe seized the pills. Allen was citated for a Class A Misdemeanor for Possession of Controlled Substance. Court date 04.07.2025 at 8am Malvern District Court. Allen was transported to Malvern PD to be processed.

#### AREA 11

Home visit conducted with the assistance of Investigator Huntsman, Investigator Vorhese, Deputy Hill, and Deputy Lacee Mondragon with the Ashley County Sheriff Department at the residence of JOHNSON, Kevin PID# 285778. Officers made contact with Johnson in the living room of the residence. Deputy Vorhese asked Johnson if he had anything in the residence that should not be in the residence. Johnson escorted Deputy Vorhese to the bathroom in the master bedroom and showed him where a meth pipe was located. Officers searched the bedroom where; Johnson's wife, Whitney Johnson ADC 713549, was currently sitting on the bed. Deputy Hill found a syringe in/or around the nightstand next to the bed that appeared to be loaded with methamphetamine along with a couple of meth pipes. While continuing the search, Officers found a second syringe that appeared to be located with methamphetamines. While Johnson and his wife, Whitney, were being placed in hand restraints, Johnson began to resist and pulled away from Deputy Mondragon. Agent Sivils and Investigator Vorhese used the least amount of physical force necessary to place Johnson in restraints. Johnson and his wife, Whitney, was charged with Possession of Controlled Substance Schedule I, II, (Meth or Cocaine) and Possession of Drug Paraphernalia. Johnson was also charged with Resisting Arrest. Johnson and Whitney were then transported to the Ashley County Detention Center.

#### TREATMENT:

2,432 probationers and parolees were served in the general Substance Use Disorder Treatment programs. Another 1,545 participants were served in the Drug Court Treatment programs, bringing the total served to 3,977 for the month.

#### **REENTRY PROGRAM:**


#### **REENTRY FACILITIES:**

As of January 31, ACC had six licensed Reentry Facilities with 193 total residents in Phases I-IV of the Reentry program. Since the program began, there have been 3,183 individuals who have successfully completed and graduated from the program. During the month, twenty-three (23) residents completed WAGE with eight (8) additional enrolling. seven (7) residents completed CRC and earned their cetificates. A total of nineteen (19) Reentry Facility residents received their driver's license, ten (10) received an ID card, thriteen (13) received their Social Security Cards and five (5) received birth certificates.

#### **REENTRY OFFICERS:**

In January, 89 Reentry residents was reported to be employed and 18 residents were reported to be ineligible for employment at this time. Reentry Officers reported seven (7) education referrals, which resulted in enrollments.

Reentry Officers conducted 151 reentry facility office visits, 63 Phase IV office visits, 14 Phase IV home visits and 21 preparole plan verifications. Reentry Officers made 38 community contacts within their assigned area during the month and conducted 62 office visits in their area. There was three (3) Good Grid classes conducted across the state with fourteen (14) referrals, eleven (11) in attendace. Three (3) job fairs were held with 32 referrals, 24 in attendance.



#### TRANSITIONAL HOUSING:

There are 16 licensed vendor facilities with 553 beds (480 DOC funded) in the facilities. Within the transitional facilities, there are 212 residents who have obtained full-time employment. In January, 275 residents who previously received their GED or high school diploma.

During the month, there were 53 registered sex offenders living in transitional facilities.

A total of 43 residents received their driver's license, 88 received an ID card, 118 received their Social Security card and 24 received birth certificates. Through new community partnerships, one (1) were enrolled in GED.

A total of 64 residents graduated from the Transitional Housing program, 45 absconded and 17 were dismissed.
