COMMUNITY SUPERVISION AREA HIGHLIGHTS:

AREA 3

On 06/26/24, ISP officers Hale and Norris were contacted by DEA TFO Dillon in regards to an arrest warrant and possible search of parolee Renford Williams. Arkansas State Police pulled Williams over in Northern White County and a warrantless search of his vehicle was conducted. This search yielded a large quantity of methamphetamines and fentanyl pills. A subsequent search was then conducted at Williams's address at 610 N. Elm St. Beebe, AR. A search warrant was obtained for this residence and Williams admitted to living here. Officers conducted a search of the property. This search yielded more illegal narcotics and a large quantity of firearms. In total, officers with DEA, DTF, White County Sheriff's Office, Arkansas State Police, and DCC seized 1,947.7 grams of methamphetamines, 239.9g of fentanyl, 800.2g of marijuana, 54.7g of cocaine, and 46g of misc. pills. Officers also seized 16 guns, 3 of which were stolen. One of the firearms also had been altered with a Glock switch. Officers also located evidence that had been used in a kidnapping and battery believed to be committed by Williams. This included a plate carrier vest and a flashlight taser.

AREA 8

On 6/21/2024, ISP Agents located Willis Clayton (PID# 0359877) white Land Rover at the Cimarron Inn in Little Rock. Clayton left the Cimarron Inn and was pulled over by LRPD due to a traffic violation.



ISP Agents conducted a search of Clayton's vehicle.
Agent Ryan Gordon located a backpack in the backseat contacting 2 semi-automatic pistols

and suspected marijuana. Also located in the vehicle was suspected Cocaine and Fentanyl Pills. ISP Agents also conducted a search of Room 137 at the Cimarron Inn, no issues or contraband found in the room.

AREA 11

On 6-20-24 Agent Parker of the Pine Bluff Probation and parole office received a phone call from Probationer Dustin Clements PID 0355503 girlfriend stating he was out of control and beat her up that morning. Agent Parker advised her to call the police then requested the assistance of **ISP Agent Johnson and Agent WIlliams** to conduct an immediate home visit. Agents went to offender clements listed address of 1131 E 2nd Avenue Pine Bluff, Arkansas 71601 and were met in the yard by the offender's girlfriend. Agents made entry into the house at that time. Agent Parker opened one bedroom door and saw offender Bobby Sanders a probationer out of Cleveland County PID 0406691 siting on a bed with a mirror laying on a pillow next to him with a line of crystal-like powder that later filed tested positive for methamphetamines. Agent Parker pulled him up and placed him in hand restraints and sent him into the living room to be supervised by Agent Williams. Laying in The bed next to offender Sanders was probation absconder Tiffany Roberts PID 0395489 Agent

Parker instructed her to come out and was sent into the living room where she was patted down and placed in hand restraints by Agent Williams who held security on her. Agent Parker then exited the room and

went through the dining room and spotted parole absconder Michael Earnest PID 0331859 leaving out of a bathroom and attempting to leave out the back door. Agent Parker grabbed him and escorted him to the living room where he was placed in hand restraints by Agent Johnson so Agent Williams could hold security on him as well as the other two

offenders. Agent
Parker then went to a
second bedroom and
located Probationer
Dustin Clements
PID 0355503. He
was escorted to the
living room where



he was placed in hand restraints by Agent Johnson. With the residence secured a search was begun by **Agents Parker and Johnson while Agent Williams** held security on the offenders. In the bedroom where Offenders Sanders and Roberts were located Agent Parker located the mirror with the line of white crystal-like substance that later field tested positive for methamphetamines. Under a pile of clothes in the floor Agent Parker located a Sonoma cigarette pack. Inside was a plastic baggie with a white crystal substance later identified as methamphetamines as well as a Tiffany Roberts drivers license. Agent Parker also located 3 home aide pipes used for smoking narcotics and a bong. In a cupboard in the dining room Agent Johnson located a syringe used for injecting narcotics and a small plastic baggie with powdery residue in it. Agent Williams called Vice and Narcotics and Detective Clark and Detective Williams from the Pine Bluff Vice and Narcotics Division arrived on scene. Detective Clark field tested the substance on the mirror and it tested

positive for methamphetamines. As a result of the home visit: Offender Bobby Sanders was charged with felony possession of methamphetamines and a probation violation report was submitted. Offender Tiffany Roberts was charged with felony possession of methamphetamines and a supplemental probation violation report was submitted. Offender Dustin Clements was charged with domestic battery III and a probation violation report was submitted. Offender Michael Earnest a true absconder was transported to the Sharp County jail to be held for 120 days SSP. sex offender services

RESIDENTIAL SERVICES:

TREATMENT:

PROGRAM SUMMARY

2,255 probationers and parolees were served in the general Substance Use Disorder Treatment programs. Another 1,749 participants were served in the Drug Court Treatment programs, bringing the total served to 4,004 for the month.

A total of 945 residents have agreed to participate in Medication-Assisted Treatment (MAT) since the program started in July 2018 with a total of 193 discharged with follow up in the cummunity in progress and a total of 164 have completed the program. Partnerships are in effect with 80 community providers to continue MAT upon release from an ACC center. In June, there were 43 active participants in the Telehealth program implemented in January 2023.

Treatment supervisors reported combined 135 hours of direct clinical supervision with Treatment staff in 32 Community Correction locations.

REENTRY PROGRAM:

REENTRY FACILITIES:

As of June 30, ACC had four licensed Reentry Facilities with 153 total residents in Phases I-IV of the Reentry program. Since the program began, there have been

over 3,100 individuals who have successfully completed and graduated from the program. During the month, 6 residents

started the Career



Readiness Certificate program and six residents completed the program. A total of ten Reentry Facility residents received their driver's license, 8 received an ID card, 16 received their Social Security card and 10 received birth certificates.

REENTRY OFFICERS:

In June, 103 Reentry residents were reported to be employed and 19 residents were reported to be ineligible for employment at this time. Reentry Officers reported four education referral, which resulted in enrollments.

Reentry Officers conducted 95 reentry facility office visits, 69 Phase IV office visits, 26 Phase IV home visits and 39 pre-parole plan verifications. Reentry Officers made 24 community contacts within their assigned area during the month and conducted 42 office visits in their area. There was three job fairs conducted across the state with 10 offender referrals.

TRANSITIONAL HOUSING:

There are 17 licensed vendor facilities with 569 beds (465 ACC-funded) in the facilities. Within the transitional facilities, there are 270 residents who have obtained full-time employment.

In June, 265 residents who previously received their GED or high school diploma.

During the month, there were 47 registered sex offenders living in transitional facilities.

A total of 27 residents received their driver's license, 102 received an ID card, 121 received their Social Security card and 34 received birth certificates.

A total of 52 residents graduated from the Transitional Housing program, 37 absconded and 22 were dismissed.


