COMMUNITY SUPERVISION AREA HIGHLIGHTS:

AREA 4

On May 23, upon arrival for a home visit of an

offender's residence, agents knocked on the door but were ignored. After several attempts, the offender opened the door but positioned herself to obstruct the view and entrance of the officers into the home. Once inside, agents discovered a known fugitive inside



the bathroom with a syringe floating in the toilet and other evidence of recent substance use. Upon further inspection, other drug paraphernalia and benzodiazepines not prescribed to the offender were located as well as a small child in the home. A urine sample was given by the offender which tested positive for methamphetamine, amphetamine, THC and MDMA. Agents notified the Department of Child and Family Services (DCFS), and the child was removed from the home. Both offenders were taken into custody by the Izard County Sheriff's Department on pending charges.

AREA 4

On or about May 13, Jonesboro Police Department officers were dispatched to an address reporting a



stolen trailer and skid steer.
Security camera footage on the building next door provided video of a white Dodge truck

pulling in the lot and leaving with the trailer. Evidence led to a search warrant of a shop building registered to the owner of the vehicle used in the theft and the skid steer was located

inside the shop. After searching the shop, a search warrant was received for a camper located adjacent to the shop



where a probationer was believed to be inside. A callout to the occupants allowed the probationer and another person to exit the camper where they were placed into custody without incident. A probation search of the vehicle was executed locating approximately 3.6 grams of marijuana, 15 - 12 ounce cans of Coors light, two bottles of Jägermeister, two bottles of Smirnoff Ice, and one glass pipe commonly used to smoke Methamphetamine with white residue consistent with Methamphetamine.

AREA 11

Upon arrival for an office visit on May 20, agents escorted an offender to his listed residence for a home search in Pine Bluff. During inspection of the home, agents found a small baggie of methamphetamines, a set of digital scales and \$853 cash on the kitchen table; a black bag containing 31 baggies with various amounts of methamphetamines, one psychedelic mushroom,

1.9 grams of Xanax, an envelope with \$522 cash, digital scales and a glass pipe for smoking methamphetamines in the kitchen oven; a bow and arrow in the bedroom closet and a glass methamphetamine pipe

in bedside table; a second bow and arrow in another bedroom and a 9mm Taurus handgun and ammo in an outside shed. The evidence was collected by the task force with charges to be adopted federally for possession of methamphetamines with intent to deliver, possession of schedule 1 drugs, possession of scheduled 2 drugs, possession of scheduled 4 drugs, possession

of firearms by certain persons, simultaneous possession of drugs and firearms and two counts of possession drug paraphernalia. The offender was transported to the Dub



Brassell Detention Center on his parole violation and later waived a hearing for 90 days.

SEX OFFENDER SERVICES

From March 10 -May 31, 2024, the Arkansas Division of Community Correction participated in the special Internet Crimes Against Children (ICAC) Division operation called Operation Cyber Highway Safety Check. The Arkansas State Police issued a press release detailing the 42 arrests made related to Child Sexual Abuse Material (CSAM) and failure to comply with registration requirements. DCC is an active member of the Arkansas Internet Crimes Against Children.

The Arkansas Crime Information Center (ACIC) released the new Arkansas Sex Offender Registry (ASOR) system. The new system replaced the CENSOR System. On-boarding for Arkansas Division of Community Correction Community Supervision Officers has begun to see full access restored. Monitoring offender sex offender registration

information is vital to sex offender accountability and management.

Noteworthy items of ASOR:

- Officers will be able to search results by Name, City, SO Registration Status (Delinquent, Address Unknown, etc.), Jurisdiction.
- Officers will be able to run a list and save to CVS file to fill in spreadsheets.
- Although DCC is NOT the law enforcement agency responsible for registration, officers will be able to upload files into offender records such as special conditions, passport, and/or professional licenses.

RESIDENTIAL SERVICES:

OMEGA SUPERVISION SANCTION CENTER (SSP)

Omega hosted a various appreciation activities during Correctional employees week giving away gift cards



and other prizes, hosting a dessert bar, snow cones and more!



SOUTHWEST ARKANSAS COMMUNITY CORRECTION CENTER (SWACCC)

Staff of the Southwest Center donated and delivered

clothing to the Bowie County Women's Recovery Center.



TREATMENT:

PROGRAM SUMMARY

2,255 probationers and parolees were served in the general Substance Use Disorder Treatment programs. Another 1,749 participants were served in the Drug Court Treatment programs, bringing the total served to 4,004 for the month.

A total of 945 residents have agreed to participate in Medication-Assisted Treatment (MAT) since the program started in July 2018 with a total of 193 discharged with follow up in the cummunity in progress and a total of 164 have completed the program. Partnerships are in effect with 80 community providers to continue MAT upon release from an ACC center. In May, there were 43 active participants in the Telehealth program implemented in January 2023.

Treatment supervisors reported combined 135 hours of direct clinical supervision with Treatment staff in 32 Community Correction locations.

REENTRY PROGRAM:

REENTRY FACILITIES:

As of May 31, ACC had four licensed Reentry Facilities with 154 total residents in Phases I-IV of the Reentry program. Since the program began, there have been

over 3,100 individuals who have successfully completed and graduated from the program. During the month, 13 residents

started the Career



Readiness Certificate program and six residents completed the program. A total of nine Reentry Facility residents received their driver's license, 22 received an ID card, 16 received their Social Security card and 13 received birth certificates.

REENTRY OFFICERS:

In May, 105 Reentry residents were reported to be employed and 21 residents were reported to be ineligible for employment at this time. Reentry Officers reported three education referral, which resulted in enrollments.

Reentry Officers conducted 149 reentry facility office visits, 122 Phase IV office visits, 36 Phase IV home visits and 45 pre-parole plan verifications. Reentry Officers made 30 community contacts within their assigned area during the month and conducted 57 office visits in their area. There was one job fair conducted across the state with 10 offender referrals.

TRANSITIONAL HOUSING:


There are 17 licensed vendor facilities with 569 beds (490 ACC-funded) in the facilities. Within the transitional facilities, there are 251 residents who have obtained full-time employment.

In May, 304 residents who previously received their GED or high school diploma.

During the month, there were 54 registered sex offenders living in transitional facilities.

A total of 29 residents received their driver's license, 103 received an ID card, 110 received their Social Security card and 39 received birth certificates.

A total of 82 residents graduated from the Transitional Housing program, 41 absconded and 16 were dismissed.
