COMMUNITY SUPERVISION AREA HIGHLIGHTS:

AREA 1

02/21/2025 Area 1 had 3 CSOs graduate the academy. AM Parker attended.

AREA 2

On February 24, Agents Cody Bruyette, Hunter Boles, and Zach Perry conducted a home visit on probationer Jessica Ellis, PID 416732, at her reported residence. While Ellis was present at the residence, the primary occupant stated that Ellis does not reside at the address. Ellis confirmed this statement and advised agents of her actual address. Agents directed Ellis to gather her belongings so that she may be transported to her residence so that a home visit could be conducted. Ellis complied with this direction but began to guzzle vodka from a bottle. Agents directed Ellis to cease this action, which is a violation of her probation, and pour the vodka out to which she complied. Agents then transported Ellis to her actual residence and conducted a compliance search of the residence which led to the discovery of multiple items of drug paraphernalia. During the search, Ellis continued to attempt to leave from where she was directed to remain by the agents. This eventually led to Ellis becoming agitated and argumentative at which point she was taken into custody and transported to Izard County Detention Center without further incident.

AREA 3

On 2/26/25, AAM Lashun Peals, along with CSA Udana Darkins and CSA Maurice Golatt participated in the 2025 Career and Education Technical Showcase as a vendor to visit with students from multiple high schools in Forrest City and neighboring areas. DCC Staff discussed employment opportunities with ADC/DCC, as well as services provided to probationers/parolees.

AREA 4

On February 22, 2025, the Poinsett County Drug Court had two (2) participants graduate the program. They are pictured with Judge Mooney in the courtroom. Congratulations to Richard Delaney and Lindsay Williams.

On February 23, 2025, Joe Barrett, Poinsett County Prosecutor donated a bicycle to the Poinsett County Drug Court for offenders to use for transportation

AREA 6

On February 1, 2025, Russellville staff participated in the Pope County Polar Plunge held at Dardanelle State Park. All money raised was donated to the Arkansas Special Olympics Association. Our staff raised \$600 plus for the event and brought home the "Guardian of the Flame" trophy for the Area 17 special Olympics. Russellville also had the most Officers participate in the Plunge. AREA 7/8

On 2/26/25, Jennings was detained at the parole office for a home visit due to complaints of suspected illegal narcotic traffic at his residence. Jenning's vehicle was searched in the parking lot and then he was transported to 818 Shea in Little Rock (parole address). Offender Jennings house key was used to make entry. Agents made contact with Angela Sanders 5/29/81 in the residence and she was escorted outside while the residence was being cleared. Agents began searching the room identified by Sanders as the room her and Jenning's share. A blue bottle cap with white powdery substance was found on the floor. The cap was taken out to LRPD Narcs, and the substance was field tested positive for Fentanyl. Agents stopped the search, and a search warrant was requested by LRPD. All evidence and the scene were turned over to LRPD. Both Jennings and Sanders were transported by LRPD to the northwest substation for questioning.

AREA 9

02/19-02/20/2025, CSA Timothy O'Malley and CSA Tiffany Parks conducted flight extradition to return LUNA, Sandra ADC#719828 from Stanislaus County (Modesto)

02/20/2025 - Tonsorial Arts Barber College provided free haircuts and shaves to Texarkana Office offenders.

02/21/2025 - CSO Mitchell and CSO Keener extradited KELLY, Noctavian ADC#162858 from Bowie County, Texas custody to Hempstead County, Arkansas custody.

02/21/2025 - Area 9 Transport team (CSA Burris and CSA Scroggins) transported MUNCEY, Billy ADC#155606 from Cooke County Jail in Gainesville, Texas to Miller County Sheriff's custody.

02/21/2025 - Area 9 Transport team (CSA Burris and CSA Scroggins) extradited GONZALES, Daniel ADC#108238 from TDCJ Huntsville Unite in Huntsville, Texas to Miller County, Arkansas.

AREA 10

02/25/2025: CSA Blake Tolleson and CSA Richard Perry conducted a random car search of offender Hoskins (0304216) resulted in 240mls of homemade moonshine. A random home visit of offender Hoskins (0304216) resulted in approximately 13.5 grams of marijuana and 46 rounds of 9mm ammunition.

AREA 11

On 3-27-25 Offender Gregory Blackwood PID 0110740 reported to Agent Dustin Parker for his regularly scheduled office visit. Due to offender Blackwood being on maximum supervision Agent Parker placed offender Blackwood in restraints so he could be transported to his residence so the required monthly home visit could be completed and requested the assistance of Agent Brooke Williams. Agents Williams and Parker transported offender Blackwood to his listed residence of 8203 Dial Road Rison, Arkansas 71665 so a home visit/compliance check could be completed. While conducting the inspection Agent Parker observed a room with the door open and looked inside. Inside the bedroom, directly to the right of the bedroom entrance on top of a chest of drawers, Agent Parker observed in plain view a black .380 Bodyguard handgun and silver 9 MM Taurus handgun. Each were loaded with one round in the chambers and full magazines. At this point, Agent Williams stepped outside of the residence to call MECA (due to having no cellular signal inside the residence) to have Jefferson County Sheriff's Office dispatched to the residence. Upon returning inside, Offender Blackwood stated that the handguns belonged to his stepfather, Jeffery Cody, and they were supposed to be secured in the gun safe. At this time, Agent Williams asked the location of the safe in order to verify it was secured. Offender Blackwood stated the safe was in the closet of Mr. Cody's bedroom. Agent Williams went to verify the safe was closed/secured, and outside the closet door Agent Williams observed a 12 gauge Harrington shot gun propped up against the wall. Agent Williams verified the shotgun was safe and placed in back in the location found until JCSO deputies

arrived. Agent Williams proceeded into the closet and located the gun safe, and it was observed the door to the safe was open. Agent Williams peered into the safe observed several long-arm firearms located inside the safe, along with boxes of ammunition. Agent Williams left the safe and firearms as is until JCSO deputies arrived. It was later determined that located in the safe were a 243 Winchester, two .22 rifles, .410, and a muzzleloader. JCSO Deputy Barnes arrived on the scene. He collected evidence and took both Agent Parker's and Williams' statements. He conferred with JCSO Captain Yohance Brunson, and it was decided all firearms would be confiscated and Offender Blackwood would be transported to JCSO CID office for interview. Agents Parker and Williams transported Offender Blackwood to JCSO CID office, and Deputy Barner transported the firearms to JCSO CID office, and Offender Blackwood was interviewed by JCSO Sgt. Clayton Cantrell. Following his interview, Sgt. Cantrell explained to Agents that the case would be prepared and presented to the Jefferson County Prosecuting Attorney to determine whether charges will be filed, and he is releasing Offender Blackwood pending the decision of the Prosecutor. The firearms would be maintained as evidence pending the outcome. At this time Agents Parker and Williams transported him back to the Pine Bluff CSO. It is of note that during this transport, Offender Blackwood made the statement he had recently helped his step-father find the combination to the safe and helped him open it. Offender was sanctioned for 1st offense possession of prohibited weapons no charges filed and was placed on daily reporting until charges for possession of firearms by certain persons are filed at which time a violation report will be completed and sent to the parole board.

2,393 probationers and parolees were served in the general Substance Use Disorder Treatment programs. Another 1,550 participants were served in the Drug Court Treatment programs, bringing the total served to 3,943 for the month.

REENTRY PROGRAM:


REENTRY FACILITIES:

As of February 28, ACC had six licensed Reentry Facilities with 201 total residents in Phases I-IV of the Reentry program. Since the program began, there have been 3,334 individuals who have successfully completed and graduated from the program. During the month, two (2) residents completed WAGE with two (2) additional enrolling. Fifteen (15) residents started CRC. A total of twenty (20) Reentry Facility residents received their driver's license, Fifteen (15) received an ID card, twenty-three (23) received their Social Security Cards and eleven (11) received birth certificates.

REENTRY OFFICERS:

In February, 136 Reentry residents was reported to be employed and 28 residents were reported to be ineligible for employment at this time. Reentry Officers reported six (6) education referrals, which resulted in enrollments.

Reentry Officers conducted 195 reentry facility office visits, 110 Phase IV office visits, 19 Phase IV home visits and 27 preparole plan verifications. Reentry Officers made 35 community contacts within their assigned area during the month and conducted 21 office visits in their area. There was two (2) Good Grid classes conducted across the state with twelve (12) referrals, five (5) in attendace. One (1) job fairs were held with 10 referrals, 3 in attendance.



TRANSITIONAL HOUSING:

There are 16 licensed vendor facilities with 553 beds (395 DOC funded) in the facilities. Within the transitional facilities, there are 212 residents who have obtained full-time employment. In February, 239 residents who previously received their GED or high school diploma.

During the month, there were 48 registered sex offenders living in transitional facilities.

A total of 33 residents received their driver's license, 75 received an ID card, 97 received their Social Security card and 16 received birth certificates. Through new community partnerships, one (1) were enrolled in GED.

A total of 39 residents graduated from the Transitional Housing program, 38 absconded and 27 were dismissed.


