FROM THE DIRECTOR: PROMOTIONS

Congratulations to the following on their recent promotions:

Lisa Wells was promoted to Assistant Area Manager in Area 2 on November 13. She will be supervising the offices in Boone, Carroll, and Newton counties. Lisa has a bachelor's degree in Criminology and Criminal Justice from the University of Missouri. PAROLE/PROBATION AREA HIGHLIGHTS:

AREA 1

On November 16-17, Parole/Probation Officers Lakyn Marciano and Heather Wineland had the opportunity to serve as guest speakers in two University of Arkansas classes comprised mainly of juniors and seniors. In each of their presentations, they explained the main duties of a Parole/Probation Officer and discussed the benefits and requirements of employment. The classes that they spoke to were extremely engaging and asked a lot of questions. At the end of each presentation, Officers Marciano and Wineland provided contact information to students who expressed interest in interning or applying for a job in the future.

On November 18, Agent Joshua McClelland and Officer Walter Riketa represented ACC at an open house for University of Arkansas students held at Homeland Security Building for all local law enforcement agencies to meet students interested in criminal justice jobs. Attendees ranged from freshman to second-year master's students. The ACC representatives distributed internship information and answered questions that the students had about the organization.

AREA 3

On November 12, White County Drug Court participants volunteered at an annual community garage sale that assists offenders with their fines and fees. According to organizers, legal fees and fines often inhibit one's ability to maintain employment and puts them in a difficult financial position.

SEX OFFENDER SERVICES (SOS)

This 10-week course is an intensive 400-hour training program focused on forensic detection of deception procedures and related disciplines. PAROLE/PROBATION HOME VISITS:

On November 2, **Area 2** Parole and Probation Agents Steve Simers and Hunter Boles, while

performing an office visit in Salem, conducted a search of an offender's vehicle. A male subject in the vehicle became apprehensive and admitted to having a firearm on his person. After safely removed the firearms, the agents conducted a search of the vehicle, which yielded the discovery of approximately 25 grams of methamphetamine and items of drug paraphernalia. In the hatch, two catalytic converters were found that were believed to have been stolen.



In November, Area 5 Parole and Probation Officer

Hunter Bruce and Officer John Hicks conducted a home visit at an offender's residence in Fort Smith. Upon entry, Officer Bruce made contact with the offender and another male, who attempted to leave the residence before Officer Bruce asked for him to step back into the residence. Officer Bruce conducted a search of the residence, and the other male was asked several times by different officers if he was on supervision, and he advised he was not. During the search of the residence, a large shard of





a crystal-like substance was found on what the other male identified as his bed. Between his bed and the offender's bed was a metal container which contained drug paraphernalia with a white crystal-like residue on it. DTF officers were contacted and arrived on scene to continue the search. Officers located a prescription bottle containing possible fentanyl pills. Officer Bruce also located two more prescription bottles in the offender's pocket, one containing a green leafy substance and anther containing more possible fentanyl and hydrocodone pills. The offender and other male were transported to the Sebastian County Detention Center by DTF officers. Once at the jail, DTF officers advised Officer Bruce that the other male was wanted through the Parole Board.

On November 9, an **Area 8** home visit was conducted at the Little Rock apartment residence of a parolee. Officers located methamphetamine in a bedside table, as well as needles, scales, baggies, and other items of drug paraphernalia. All evidence was turned over to the Pulaski County Sheriff's Office and the parolee was charged with Possession with Purpose to Deliver Methamphetamine, Possession of Drug Paraphernalia and Maintaining a Drug Premises.

On November 16, an Area 11 home visit was conducted by ISP Agent Anthony Spadoni, Agent Tiffany Doss and Agent Tonya Robinson. Contact was made with the offender. Officers entered to the house to search. Upon entering the house Agent Doss asked the



offender if there were any weapons or illegal drugs inside the residence. The offender stated that there was a gun under the pillow on his bed. The offender was detained for officer safety. Agent Spadoni went to the bed and turned the pillow over and located a Rossi Revolver .38 Special fully loaded. Agent Spadoni and Agent Robinson continue a search of the residence. Officers noticed a door with a padlock and asked the offender if he had a key to the room. The offender stated that he did and also stated that there were drugs in that room. Upon entering the room Agent Spadoni located a rock-like substance which turned out to be cocaine on top of a box just inside the door. Agent Spadoni also located a pill bottle that had a white rock-like substance located inside of it. Agent Robinson located a pickle jar on the other side of the room which had marijuana in it. Pine Bluff Police Department was notified and sent an officer out. Narcotics was also notified. A Narcotics officer arrived and took possession of the drugs and the firearm.

RESIDENTIAL SERVICES:

EAST CENTRAL ARKANSAS COMMUNITY CORRECTION CENTER (ECACCC)

Two West Memphis ministry groups donated hygiene products to the center during the month of November. Wailing Women and Men's



Ministry donated more than 200 items, while members of the Missouri Street Church of Christ donated around 7,000 items.

Also during the month, ECACCC collected canned goods and nonperishable foods to support the local 8th Street Mission in West Memphis.

TREATMENT:

PROGRAM SUMMARY

1,575 probationers and parolees were served in the general Substance Use Disorder Treatment programs. Another 1,584 participants were served in the Drug

TREATMENT, continued:

Court Treatment programs, bringing the total served to 3,159 for the month.

A total of 729 residents have agreed to participate in Medication-Assisted Treatment (MAT) since the program started in July 2018. A total of 422 were discharged with follow up in the community in progress and 105 have completed the program.

Partnerships are in effect with 78 community providers to continue MAT upon release from an ACC center. The grant ended on September 30, 2022. The State Opioids Response (SOR) III grant award from the Division of Aging Adult and Behavioral Health Services (DAABHS) is pending for the third cycle of the grant that allows continuation of the MAT program as of October 2022. At this time, the anticipated funds release date is December or January.

An Intensive Case Management pilot program in the North Little Rock Parole/Probation Office (Area 8) began in September 2021 and currently has one active participant.

Treatment staff participated in November training that included: UAMS Tobacco Cessation Training for Healthcare Providers, Supervisor's Refresher Course and a Findhelp.org presentation.



General Treatment Program Summary

REENTRY PROGRAM:

REENTRY FACILITIES:

As of November 30, ACC had six licensed Reentry Facilities with 184 total residents in Phases I-IV of the Reentry program. Since the program began, a total of 2,728 individuals have successfully completed and graduated from the program. There was a total of 16 reentry graduates during the month.



Career Readiness Certificate program and 15 residents completed the program. A total of 17 Reentry Facility residents received their driver's license, six received an ID card, 13 received their Social Security card and seven received birth certificates.

REENTRY OFFICERS:

In November, 134 Reentry residents were reported to be employed and 13 residents were reported to be ineligible for employment at this time. Reentry Officers reported six education referrals that resulted in education enrollment.

Reentry Officers conducted 158 reentry facility office visits, 128 Phase IV office visits, 18 Phase IV home visits and 74 pre-parole plan verifications. Reentry Officers made 32 community contacts within their assigned area during the month and conducted 83 office visits in their area.

TRANSITIONAL HOUSING:

There are 20 licensed vendor facilities with 569 beds (454 ACC-funded) in the facilities.

Within the transitional facilities, there are 280 residents who have obtained full-time employment.

In November, two residents reported to have enrolled in GED classes and there are 313 Transitional Housing facility residents who previously received their GED or high school diploma.

During the month, there were 45 registered sex offenders living in transitional facilities.

A total of 55 residents received their driver's license, 159 received an ID card, 164 received their Social Security card and 42 received birth certificates.

A total of 71 residents graduated from the Transitional Housing program, 44 absconded and 23 were dismissed.

Note that these officers may also carry regular P/P offenders, and these offenders are reflected in the specialty court caseload/workload figures; however, separate caseload/workload ratios are calculated for the regular and specialty court portions of a specialty court officer's caseload, in addition to a combined, or mixed, ratio.

Specialized: These officers supervise strategically specialized caseloads consisting of offenders requiring heightened supervision protocols (intensive supervision) and parolees who have absconded supervision (Special Response Team).

Indirect: These are offenders for whom their sentence, circumstance, or current status is associated with a reduced supervision obligation for the officers they are assigned to. Generally, these include offenders in non-reporting status, those on suspended sentences (SIS), and interstate compact offenders. Offenders on annual supervision are also included in this group.


