FROM THE DIRECTOR: PROMOTIONS

AREA 1

In January 2023, 100 participants completed 741 hours of community service.

AREA 2

On January 19, Assistant Area Manager Eva Frame was elected co-chairman of the Drug Free Community Grant Initiative. The program will now be called PAYS (Prevention Awareness Youth Support). A Meth Prevention Conference will be held on February 24.

January 23-24, Agent Charley Slater, Agent David Beaty, and Officer Alec Wilbur, accompanied by agents of the 14th Judicial District Drug Task Force, made home visits in the Baxter/Marion County area that resulted in the discovery of multiple firearms and controlled substances in the possession of active parolees or probationers. The evidence was retained by the DTF and the offenders were taken into custody with new felony charges pending.

In January, 27 participants completed 432.5 hours of community service.

AREA 3

Newport Probation/Parole officers conducted searches of several offenders' residences in Jackson County January 25. They were assisted by the Lonoke P&P Office, ISP officers, Jackson County Sheriff's Office, Newport Police Department, and Tuckerman Police Department. The home visits resulted in 16 felony arrests.

ACC DIRECTOR'S BOARD REPORT, February 2023

The Randolph/Lawrence County Drug Courts held a Commencement Ceremony January 26 at the Pocahontas Community Center. Drug court graduates described their journeys in maintaining their sobriety and how the program helped them reconnect with children and families.

In January, 117 participants completed 2,371 hours of community service.

AREA 4

Area 4 Probation/Parole Agent Ashley Stuart and Jonesboro Police Lt. Nathan Coleman were invited to attend the January 4th Jonesboro Exchange Club meeting as Jonesboro Fraternal Order of Police Lodge #8 representatives. On January 30, management, agents, and FTOs from Area 12 offices and a Sergeant from the SWACCC completed the course.

SEX OFFENDER SERVICES

January was Human Trafficking Awareness Month.

Jennifer Dean Jordan and Kenny Kendrick, Area Manager and Assistant Area Manager of Sex Offender Services, respectively, continued training of Child Abduction Response Teams (CART) statewide. Training consisted of an introduction to sex offender management and victimology. Areas trained in January were CART, located within the jurisdiction of Arkansas State Police Troop I (Harrison); Troop D (Forrest City); and Troops E and F (White Hall). Training is ongoing through March.

PAROLE/PROBATION HOME VISITS:

January 23-24 in Area 2, Agent Charley Slater, Agent David Beaty, and Officer Alec Wilbur, accompanied by agents of the 14th Judicial District Drug Task Force, performed home visits in the Baxter and Marion counties, which resulted in the discovery of multiple firearms and controlled substances in the possession of active parolees or probationers. HOME VISITS, continued:

ISP in conjunction with the DEA Task Force conducted a home visit January 4 in Little Rock. Credible information had been received that a probation absconder was living at that address. The offender was at the residence. A handgun was located on the couch in the living room and suspected fentanyl was found in the toilet. The scene and evidence were turned over to the task force for a search warrant.

In January, Area 8 Agents were driving down Arkansas River Trail in Maumelle when two offenders were spotted walking towards the Kum and Go Gas Station. Agents followed them to the station and verified their identities. One offender was on active supervision and on the SSP Backup list. The other offender was a parole absconder with active warrants out of Faulkner County. Agents placed offenders in restraints and transported them to their residence, which was then searched. One offender was released at the residence and the other was transported to the Little Rock Parole Office.

On January 20-23 in Area 11, Crossett, El Dorado, and Monticello Probation/Parole Officers and Agents assisted SRT and DTF in home visits of offenders with active warrants or involved in suspected illegal activities.

TREATMENT:

PROGRAM SUMMARY

1,601 probationers and parolees were served in the general Substance Use Disorder Treatment programs. Another 1,612 participants were served in the Drug Court Treatment programs, bringing the total served to 3,213 for the month.

A total of 750 residents have agreed to participate in Medication-Assisted Treatment (MAT) since the program started in July 2018. A total of 434 were discharged with follow up in the community in progress and 114 have completed the program.

Partnerships are in effect with 78 community providers to continue MAT upon release from an ACC center. Funds for the third cycle of the State Opioids Response (SOR) III grant from the Division of Aging Adult and Behavioral Health Services (DAABHS) were released, allowing for continuation of the program.

An Intensive Case Management pilot program in the North Little Rock Parole/Probation Office (Area 8) began in September 2021 and currently has one active participant. Activities in January included mental health service referrals in the community.

In January, there were two active participants in the newly implemented Telehealth program.

SPECIAL ACTIVITIES

AREA 5:

Ongoing partnership with The Guidance Center (TGC) in Fort Smith assisted probationers/parolees with mental health/cooccurring disorder with medication and counseling services. The referrals to TGC has also been helpful with ACC Treatment staff's caseload for that population.

AREA 6:

Faulkner County Drug Court staff joined Community Action Program of Central Arkansas (CAPCA) in their Project Homeless event in Conway. The event connected attendees with various services in the community. Staff served hot meals and provided care kits and shoes to those in need.

In addition to network activities with local Medication Assisted Treatment providers and residential treatment center, Conway County Drug Court staff partnered with a Peer Recovery Specialist to facilitate day time support groups in the local ACC

office. This has been helpful for participants with challenges attending night time support groups in the community due to other obligations.

AREA 11:

Cares Behavioral Health a local mental health provider in collaboration with Substance Abuse Program Leader in Pine Bluff Office has resumed inperson services since COVID lockdown. Attendance looks good with approximately 75% of participants reporting as scheduled.

ONGOING PROJECTS:

Treatment supervisors reviewed staff development plans with each staff and set goals and objectives for the new year. All Treatment staff are currently within policy required credentialing timeline.

Treatment supervisors reported combined 222 hours of direct clinical supervision with Treatment staff in 37 ACC locations.

REENTRY PROGRAM:

REENTRY FACILITIES:

As of January 31, ACC had six licensed Reentry Facilities with 174 total residents in Phases I-IV of the Reentry program. Since the program began, a total of 2,810 individuals have successfully completed and graduated from the program. There was a total of 21 reentry graduates during the month.

During the month, 12 new residents were transferred into the Reentry program, one resident completed their GED and 11 residents started the Career Readiness Certificate program. A total of 13 Reentry Facility residents received their driver's license, 14 received an ID card, 7 received their Social Security card and 12 received birth certificates.

REENTRY OFFICERS:

In January, 73 Reentry residents were reported to be employed and 23 residents were reported to be ineligible for employment at this time. Reentry Officers reported 10 employment referrals, which resulted in two receiving employment.

Reentry Officers conducted 104 reentry facility office visits, 118 Phase IV office visits, 32 Phase IV home

visits and 42 pre-parole plan verifications. Reentry Officers made 17 community contacts within their assigned area during the month and conducted 32 office visits in their area.

TRANSITIONAL HOUSING:

There are 20 licensed vendor facilities with 593 beds (454 ACC-funded) in the facilities.

Within the transitional facilities, there are 88


residents **Population by Reentry Facility** who have obtained 15; 12% full-time 31; 25% 15; 9% Covenant Malvern employment. Hidden Creek 12; 8% Hope Rises In January, In His Wings Twin Lakes one resident 24; 15% Wings to Recover reported to 32; 31% have enrolled in GED classes and

there are 103 Transitional Housing facility residents who previously received their GED or high school diploma.

During the month, there were 19 registered sex offenders living in transitional facilities.

A total of 20 residents received their driver's license, 87 received an ID card, 93 received their Social Security card and 16 received birth certificates.

A total of 50 residents graduated from the Transitional Housing program, 51 absconded and 24 were dismissed.

Note that these officers may also carry regular P/P offenders, and these offenders are reflected in the specialty court caseload/workload figures; however, separate caseload/workload ratios are calculated for the regular and specialty court portions of a specialty court officer's caseload, in addition to a combined, or mixed, ratio.

Specialized: These officers supervise strategically specialized caseloads consisting of offenders requiring heightened supervision protocols (intensive supervision) and parolees who have absconded supervision (Special Response Team).

Indirect: These are offenders for whom their sentence, circumstance, or current status is associated with a reduced supervision obligation for the officers they are assigned to. Generally, these include offenders in non-reporting status, those on suspended sentences (SIS), and interstate compact offenders. Offenders on annual supervision are also included in this group.
