#### **POPULATION REPORT**

#### RESEARCH/PLANNING

**January 2024 Admissions and Releases** – Admissions for January 2024 totaled **415** (349-males and 66-females) while releases totaled **404** (336-males and 68 females) for a net increase in-house of 11 inmates.

Inmate Population Growth/Projection – At the end of January 2024, the jurisdictional population for the Division of Correction totaled **18,522**, representing an increase of **19** inmates since the first of January 2024. At reporting time, calendar year 2024 has seen an average growth rate of **19** inmates per month, which is down from an average monthly increase of **71** inmates per month during calendar year 2023.

**Average County Jail Backup** – The backup in the county jails averaged **1,691** inmates per day during the month of January 2024, which was up from the per-day average of **1,663** inmates during the month of December 2023. Of the **1,691** average, short-term revocations accounted for **269** (221 males and 49 females) during the month.

#### **INSTITUTIONS**

#### INMATE INSTITUTIONAL GRIEVANCES

**Inmate Formal/Informal Grievances:** During January, a total of 1,139 formal grievances and 1,599 informal grievances were filed at various units.

**Institutional Grievances Appeals:** There was a total of 437 appeals of institutional grievances received in January. Of those, 260 were acknowledged and 177 were rejected for various reasons. Of the total, 219 appeals answered, 216 had no merit and three had merit.

#### **FARM DIVISION**

All unit farms took advantage of the down time to complete maintenance repairs of the planting equipment in preparation for the upcoming season. Meanwhile, farm managers met with the seed vendor on a plan to match varieties to soil types, fertility programs and herbicide programs.

The beef herds did well during the freezing snow conditions, but more hay was fed to the cattle during this time.

Dairy production is at an increase of 997 gallons for January 2024 production in comparison to January 2023.

Egg production decreased this month due to the cold temperatures. The new flock of layers will move over the end of February.

The annual garden meeting was held with the highest attendance from all gardens across the state. New ideas on production improvements make it hopeful for a promising year.

The average time on the waiting list from request is 22 days.

\*The total on the waiting list, including those not currently within the identified timeframe, is 3,928 males and 433 females. Of these, 3,187 are eligible and 1,174 are ineligible for the program.

\*Ineligibility is due to being in restrictive housing, having class IV status, or receiving a major disciplinary within the last 60 days.

## Ouachita River Correctional Unit (ORCU) Residential Program Unit (RPU):

The RPU had one admission and four discharges in January for an end-of-month count of 115.

## McPherson Unit Mental Health Residential Program Unit (RPU):

There were four admissions and four discharges in January for an end-of-month count of 40.

#### **Habilitation Program:**

The Habilitation Program at the Ouachita River Correctional Unit provided treatment services to 43 inmates in January. There were zero admissions and zero discharges, which resulted in an end-of-month count of 43.

#### **Anger Management Treatment:**

The Anger Management Treatment Program at the Cummins Unit did not provide treatment services to any inmates in January. There were no admissions or discharges, for an end-of-month count of zero.

#### Suicide:

There were 98 suicidal threats in January. There were 15 attempts, none of which resulted in death.
