POPULATION REPORT

RESEARCH/PLANNING

March 2023 Admissions and Releases – Admissions for March 2023 totaled **481** (394-males and 87-females) while releases totaled **380** (313-males and 67 females) for a net increase in-house of 101 inmates.

Inmate Population Growth/Projection – At the end of March 2023, the jurisdictional population for the Division of Correction totaled **18,075**, representing an increase of **427** inmates since the first of March 2023. At reporting time, calendar year 2023 has seen an average rate of **142** inmates per month, which is up from an average monthly increase of **52** inmates per month during calendar year 2022.

Average County Jail Backup – The backup in the county jails averaged **1,970** inmates per day during the month of March 2023, which was up from the per-day average of **1,834** inmates during the month of March 2022. Of the **1,970** average, short-term revocations accounted for **505** (418 males and 87 females) during the month.

House Bill 1530/Restrictive Housing (RH) - January 1, 2023 through March 31, 2023 –

- There was a 0.6% decrease in overall RH assignments during the first quarter of 2023 compared to the fourth quarter of 2022.
- There was a 7.2% increase in the number of major disciplinarys this quarter.
- There was a slight decrease in those aged 55 or older, but a slight increase in those aged 21 or younger and those with an SMI diagnosis who were held in RH, as compared to the fourth quarter.
- There were zero suicides during the quarter and a 40% decrease in the number of suicide attempts compared to the previous quarter.
- This quarter, there were zero deaths of those who were housed in RH, which is a decrease compared to the fourth quarter.
- There was no change in the number of inmates assigned to RH for Protective Custody compared to the previous quarter.

INSTITUTIONS

INMATE INSTITUTIONAL GRIEVANCES

Inmate Formal/Informal Grievances: During March, a total of 1,329 formal grievances and 1,786 informal grievances were filed at various units.

Institutional Grievances Appeals: There was a total of 567 appeals of institutional grievances received in March. Of those, 414 were acknowledged and 153 were rejected for various reasons. Of the total 431 appeals answered, 427 had no merit and four had merit.

FARM DIVISION

Most of March was wet, which affected row crop planting. But since most of our target dates for planting are in April, our timing is still okay.

Egg production started rising to more than 35,000 per day. As a result, we are again able to provide eggs for all units.

Calving continues at both Wrightsville and Cummins. Plans are underway to get all pastures sprayed early this year so that our fertility plan for hay fields can be implemented. The plan calls for using electric fencing to graze pastures on a rotational basis. This will be a more efficient way to graze and utilize all available grass.

The gardens are being planted as the rain allows. We should have fresh produce coming into the kitchens within 30-45 days.

CHAPLAINCY SERVICES AND COMMUNITY SPEAKING EVENTS
