POPULATION REPORT

RESEARCH/PLANNING

November 2022 Admissions and Releases – Admissions for November 2022 totaled **343** (259-males and 84-females) while releases totaled **399** (309-males and 90 females) for a net decrease in-house of 56 inmates.

Inmate Population Growth/Projection – At the end of November 2022, the jurisdictional population for the Division of Correction totaled 17,521, representing an increase of 498 inmates since the first of January 2022. At reporting time, calendar year 2022 has seen an average rate of 45 inmates per month, which is down from an average monthly increase of 77 inmates per month during calendar year 2021.

Average County Jail Backup – The backup in the county jails averaged 1,772 inmates per day during the month of November 2022, which was up from the per-day average of 1,730 inmates during the month of October 2022. Of the 1,772 average, short-term revocations accounted for 487 (406 males and 81 females) during the month.

INSTITUTIONS

INMATE INSTITUTIONAL GRIEVANCES

Inmate Formal/Informal Grievances: During November, a total of 1,100 formal grievances and 1,682 informal grievances were filed at various units.

Institutional Grievances Appeals: There was a total of 450 appeals of institutional grievances received in November. Of those, 336 were acknowledged and 114 were rejected for various reasons. Of the total 332 appeals answered, 330 had no merit and two had merit.

FARMS

Wheat crops were planted at all ADC farms in November – a total of 3,800 acres this year. About 1,500 acres of wheat was planted at the Cummins and Tucker units for early spring grazing. Cover crop was planted at the East Arkansas Regional Unit farm to help build the soil, reduce erosion, and add nutrients back into the soil. The same was done at Cummins on the ground that was leveled last year.

A lot of fresh produce was gathered from the gardens during the month, with Vegetable Processing shipping out as much of it as possible.

During the month, egg production consistently averaged 35,000 daily, which is where it needs to be to keep up with

the demand. The dairy was faced with working through a spike in the somatic cell count in the milk. The cows were started on a new vaccine that will hopefully better control the issue.

Beef herds have weaned all of the calves. Steers are scheduled to be sold in January through Superior Livestock Auctions. All heifers will be retained and evaluated in April for replacements.

Horses were identified for the annual horse auction scheduled for March 11, 2023. While 48 were found to be eligible for the sale, that number will be narrowed down to 28-30 when the horses are picked up in December and January.






