## Impact Assessment for HB1125 Sponsored by Representative Evans

## **Subtitle** TO PROHIBIT A REGISTERED SEX OFFENDER FROM PURCHASING, OWNING, POSSESSING, USING, OR OPERATING AN UNMANNED AIRCRAFT FOR PRIVATE USE.

**Impact Summary**<sup>1</sup> Minimal. While the proposed bill creates a new criminal offense for which the likely number of occurrences cannot be determined, similar criminal offenses have not resulted in a significant impact on correctional resources.

**Change from Current Law<sup>2</sup>** Amends various provisions of the Arkansas Code Annotated regarding prohibited conduct for certain registered sex offenders. The proposed bill creates a new criminal offense. Under the proposed bill it is a Class D felony for a person who is required to registered under the Sex Offender Registration Act and who has been assessed as a Level three (3) or four (4) offender to knowingly purchase, own, possess, use, or operate an unmanned aircraft.

The proposed bill also creates a notification requirement for offenders subject to this restriction, defines "unmanned aircraft," and creates an exception for offenders who are required to purchase, own, possess, use, or operate an unmanned aircraft as part of their employment.

**Impact Information** The proposed bill creates a new criminal offense for which the likely number of occurrences cannot be determined. However, other similar provisions have not historically had a significant impact on correctional resources. For this reason, the projected impact of the proposed bill is minimal. The data below demonstrates the impact of others sex offender restrictions.
